- ESNZ Membership/Registrations and Levies are correctly described refer page 11 and 12.
- We recommend using the table on page 12 as well as description on page 11.
- Your Show Conditions must be included. Think about refund policy, yarding policy, and other specific conditions for your event.
- **Your POGJ has reviewed the schedule.**

## TAXING PRIZE MONEY

- For Professional Riders - Prize Money of more than \$500 in a single event requires withholding tax to be deducted on the amount exceeding \$500. (IR330c) Refer IRD Tax rules for Prize Money <https://www.ird.govt.nz/income-tax/income-tax-for-businesses-and-organisations/types-of-business-income/amateur-and-professional-sportspeople>

# 2023/2024 ESNZ JUMPING AND CASUAL LEVIES (flexi-start)

**\$7 ESNZ Jumping Levy** (Compulsory) – payable for all horses/ponies competing in Jumping and or Show Hunter.

## ***ESNZ Casual Equine & Jumping/SH Discipline Flexi-start (Equine only)***

- Can compete up to 1.00m on a pony and up to 1.10m on a horse. Cannot compete in any Jumping or Show Hunter series classes and will not be eligible for HOYQ in SH.
- The rider must be a full member with ESNZ.

### **❑ *\$30.15 ESNZ Casual Equine & Jumping/SH Discipline (which includes Flexi-Start for Equine) per show***

Where an **equine is not registered with ESNZ**, the fee will be \$30.15 (includes Flexi-Start)

### **❑ *\$25 Jumping/SH Discipline Flexi-start (Equine only) per show***

Where an **equine has an Equine registration but no annual Jumping start**. This fee is \$25.

## ***\$16.30 Casual Day Membership (Rider only) per day***

- Riders may compete in Introductory class (80cm and under on ponies and 90cm and under on horses) on an introductory or casual membership. All other riders must be full members with ESNZ.

# BEFORE YOUR SHOW – National Series Sponsors

## **National Series Sponsors**

- Please ensure National Series Sponsors are invited to your show to present, watch and enjoy your hospitality. This is compulsory for Special Shows, Premier and World Cup Shows.
- When assigning a local sponsor to support/sponsor a series class please ensure their business does not conflict with the National Sponsor (e.g. Dunstan Horsefeeds Amateur Rider must not have another feed company as local sponsor)

## **National Series Sponsor Flags/Corflutes**

- Please ensure the National Series Sponsor Flags and Corflutes (for Show Hunter) are set up around the main competition area.
- Compulsory for all Special Shows, Premier and World Cup Shows to display the flags.

# BEFORE YOUR SHOW – Entries

- ❑ All officials, riders and equines at your show need to have current registrations to be eligible to compete or officiate at your show.
- ❑ If they are expired, you must notify the person asap for renewal, which they can do online.

Riders are not eligible to compete without the appropriate membership and registration.

**You can check this information through your entry software – EvoEvents and Main-Events.**

- ❑ Horses in 5, 6, 7 year old Breeders Series must have proof of age PLUS details of Sire, Dam and Sire of Dam (this is available to you through your entry software).
- ❑ Riders in **Amateur and Pro-Am Series must be listed as owner or registered leasee** of equine.
- ❑ Riders competing with more than one horse in the rider series (**Young Rider, Junior Rider, Amateur Rider or Pro-Amateur Rider**) must nominate their point scoring horse and ride that horse first.

# BEFORE YOUR SHOW – Officials

# ESNZ OFFICIALS – Recommended Pay Rates

The following pay rates are a guideline only. The current IRD mileage rate is 83c per km.

## ***Judges***

- FEI Level & President of the Ground Jury \$200 per day
- National Level 2 & 3 \$150 per day
- National Level 1 \$100 per day

## ***Stewards***

- FEI level & Chief Stewards \$200 per day
- National Level 3 \$150 per day
- National Level 2 \$100 per day
- National Level 1 (assisting only) no fee (in training)

## ***Course Designers***

- FEI Level 3 \$350 per day
- FEI Level 2 \$300 per day
- National Level 2, 3 and FEI Level 1 \$250 per day
- National Level 1 \$200 per day

## ***Technical Delegates***

- FEI Level \$200 per day
- Levels 2 & 3 \$150 per day
- Level 1 \$100 per day

## OFFICIALS – Course Designers - refer Art 259 JRs

### 5.1. Course Designers (refer Art 259 JRs)

- ▶ 5.1.1. In National, Island, Young Horse Jumping Championships, Special competitions at the HOY show and Premier competitions Course Designers must be selected from a ESNZ Jumping list of Official National Course Designers and appointed with the agreement of the ESNZ Jumping Board.
- ▶ 5.1.2. At Grand Prix events the course designer in the feature arena must be chosen from the ESNZ Jumping list of National Level 2 or National Level 3 Course Designers by the Organising Committee.
- ▶ 5.1.3. At all other carded events, the course designer must be chosen from the ESNZ Jumping list of National Level 1,2, or 3 Course Designers by the Organising Committee.

# OFFICIALS –Technical Delegates – refer Art 259 JRs

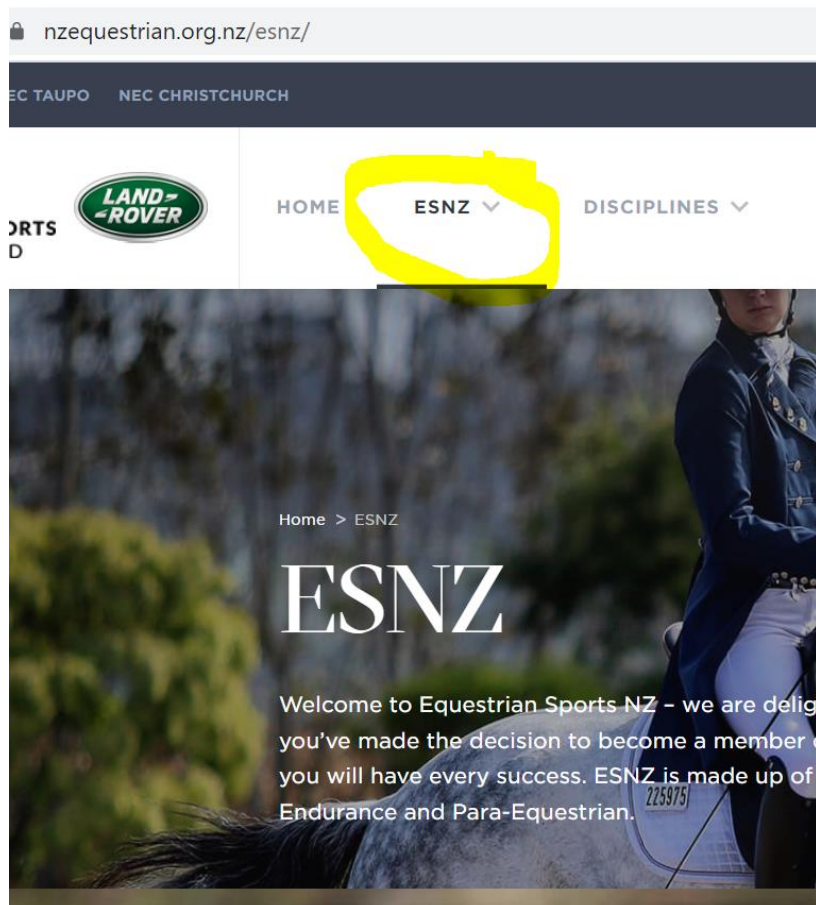
## Technical Delegate

- 5.2.1. In National, Island Championships and the HOY show a Technical Delegate from the ESNZ Jumping lists of Technical Delegates or a National Level 3 Course Designer appointed by the ESNZ Jumping Board is compulsory.
- 5.2.2. A Technical Delegate selected from the ESNZ Jumping list of Technical Delegates or National Level 3 Course Designers should be appointed by the organising committees of Premier events and Young Horse Jumping Championship.
- 5.2.3. For all other events a Technical Delegate selected from the ESNZ Jumping list of Technical Delegates, National Level 2 or National Level 3 Course Designers may be appointed by the organising committee.

## OFFICIALS – Stewards – refer Art 259 JRs

- A Chief Steward must always be appointed for NZ and Island Championships, Premier events, Young Horse Jumping Championships and the HOY show from the list of National FEI Stewards. These are appointed in conjunction with the Jumping Board.
- Any show running National Jumping Series classes must have a National Level 3 or above Steward.

# HEALTH AND SAFETY

*Accidents happen  
anywhere – be prepared*

Do not begin your show until Medical cover is available on the grounds, this includes warm-ups over jumps of any kind.

Advertise contact for Vet On Call at office.

Have a screen available and make sure committee and officials know how to use it. Consider a practice run prior to the show starting.

Consider Horse Ambulance, and as a minimum have a float readily available and hooked up to a car ready to go.

All technical officials must be issued with a contact list for vet, medical personnel, President of the Ground Jury and other key committee / technical official contacts.

# FALLS AND INCIDENT REPORTING

**All falls must be checked by medic & All incidents must be recorded.**

1. Minor non-injury incidents only require logging on medic summary sheet, to be sent at conclusion of show to [jumping@nzequestrian.org.nz](mailto:jumping@nzequestrian.org.nz)
2. Incidents with any form of injury are to be recorded either by using (preferably) the online incident report form <https://www.nzequestrian.org.nz/safety/online-incident-report/> or the manual form. All manual incident report forms should be sent to [jumping@nzequestrian.org.nz](mailto:jumping@nzequestrian.org.nz)
3. All major and extreme incidents as well as all concussion related incidents will be followed up by ESNZ.
4. **Any suspected concussion** should be listed as the rider receiving a blue card. ESNZ to be advised so the Blue Card can be recorded on file. Advise Kirsten or Marilyn. 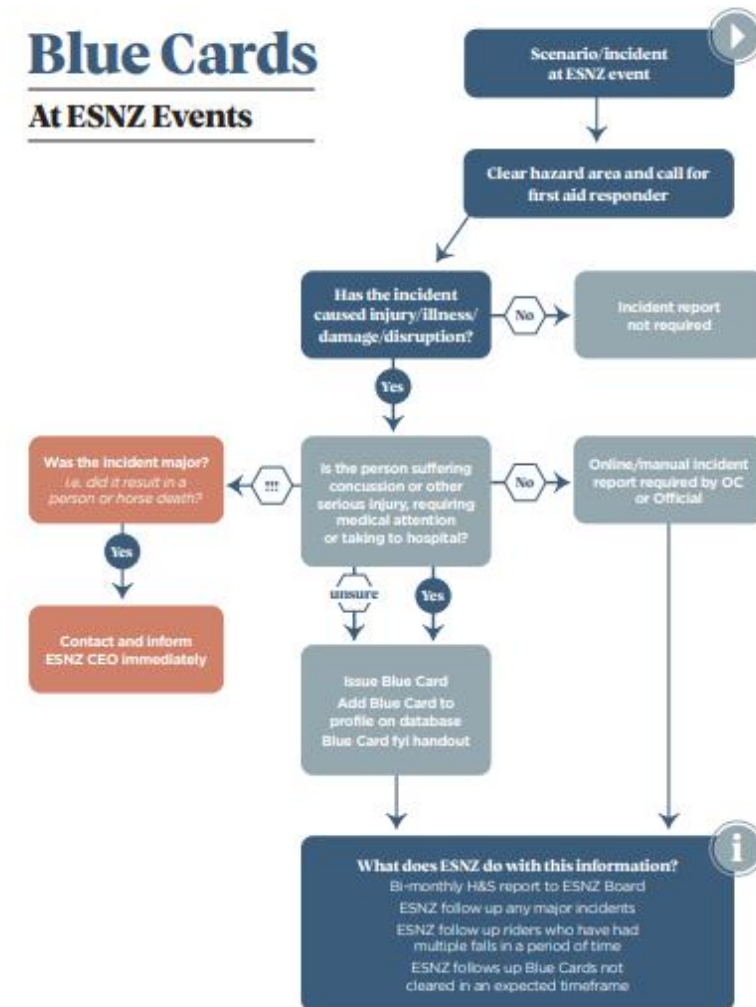
# BLUE CARD REPORTING

## **General Regs - Article 153: Minimum Standards for Medical Personnel and Services at NF Events**

**REFER TO ATTACHED DOCUMENT – PAGES FROM GEN REGS for detailed descriptions of Medical Personnel and Resources**

## General Regs - Article 153: Minimum Standards for Medical Personnel and Services at NF Events

Must appoint a Medical Co-Ordinator who will be responsible for ensuring the medical arrangements for the Event meet both ESNZ General Regulations and any Discipline Rules with regards to medical standards.

The Medical Co-Ordinator must undertake a risk management analysis (taking into account the level of emergency services available in the area and the distance and travel time to and from the event to reach those medical services to ascertain whether a level of medical cover above the minimum standard should be provided at the event).

- Identified the number and location for First Aid/Treatment Centre/s needed for the event which will depend upon the layout and size of the event location and the potential number of people attending the event including competitor and their support people plus spectators.
  - First Aid/ Treatment Centre/s which must be private and ideally quiet where first aid or further medical support can be received (see Summary Table )
  - There must be rapid access to and from the First Aid/Treatment Centre/s to all areas of the Event for an ambulance or Rapid Response Vehicle. The access routes must remain free and unblocked throughout the event.
  - First Aid/Treatment Centre/s must be provided with good communication resources including access to radio communication with officials and phone/mobile communication with Emergency Services
- The Medical Co-ordinator must notify local after-hours Emergency services of the event dates and potential injuries seen at equestrian events.
- Must have an agreement in place with the venue/property owner as to who is responsible in case of emergency before the event begins and after it finishes.

# The minimum standard of medical personnel and resources

**The minimum standard of medical personnel and resources** that must be provided on-site during a Jumping/Show Hunter event are as follow:

1. Minimum medical personnel on-site during the hours of competition and located at the first aid/medical centre/s
  - ❑ For Events with up to 100 riders - a First Aider or First Responder (see Annexes J and K) with access to a First Aid Kit
  - ❑ For Events with over 100 riders - minimum of Emergency Medical Technician with access to a fully equipped EMT Kit, plus a First Aider or First Responder with access to a fully equipped First Aid Kit
2. Minimum medical resources on-site during the hours of competition and located at the first aid/ treatment centre/s are:
  - ❑ **Fully equipped EMT Kit**, or First Aid Kit conforming to the requirements of a Workplace First Aid Kit as defined by Worksafe's Good Practice Guide. (<https://worksafe.govt.nz/managing-health-and-safety/businesses/general-requirements-for-workplaces/>) (see Annex J)
  - ❑ **Rapid response vehicle** (see Annex J). If a fully equipped ambulance is provided this can function as the event's First Aid/ Medical Centre. All events must also comply with discipline safety and medical rules as set out in the discipline rules.



# Legal System – General Regs – Chapter 9

## Ground Jury

The judicial role of the GJ is to promptly and fairly deal with matters and issues that are directly connected with a Competition or Competitions at an Event that may affect the outcome or result of the Competition

The jurisdiction of the GJ and Appeal Committee begins one hour before the start of the first Competition, or at the commencement of the event, as specified in the schedule and extends until 60 minutes after the conclusion of the last Competition at an Event

**NEW\*\* No fee payable for complaints about horse or human welfare.**

## Protests:

on the day, to the Ground Jury, not later than 60mins after completion of event, \$50 lodgment fee.

## Protest flow chart



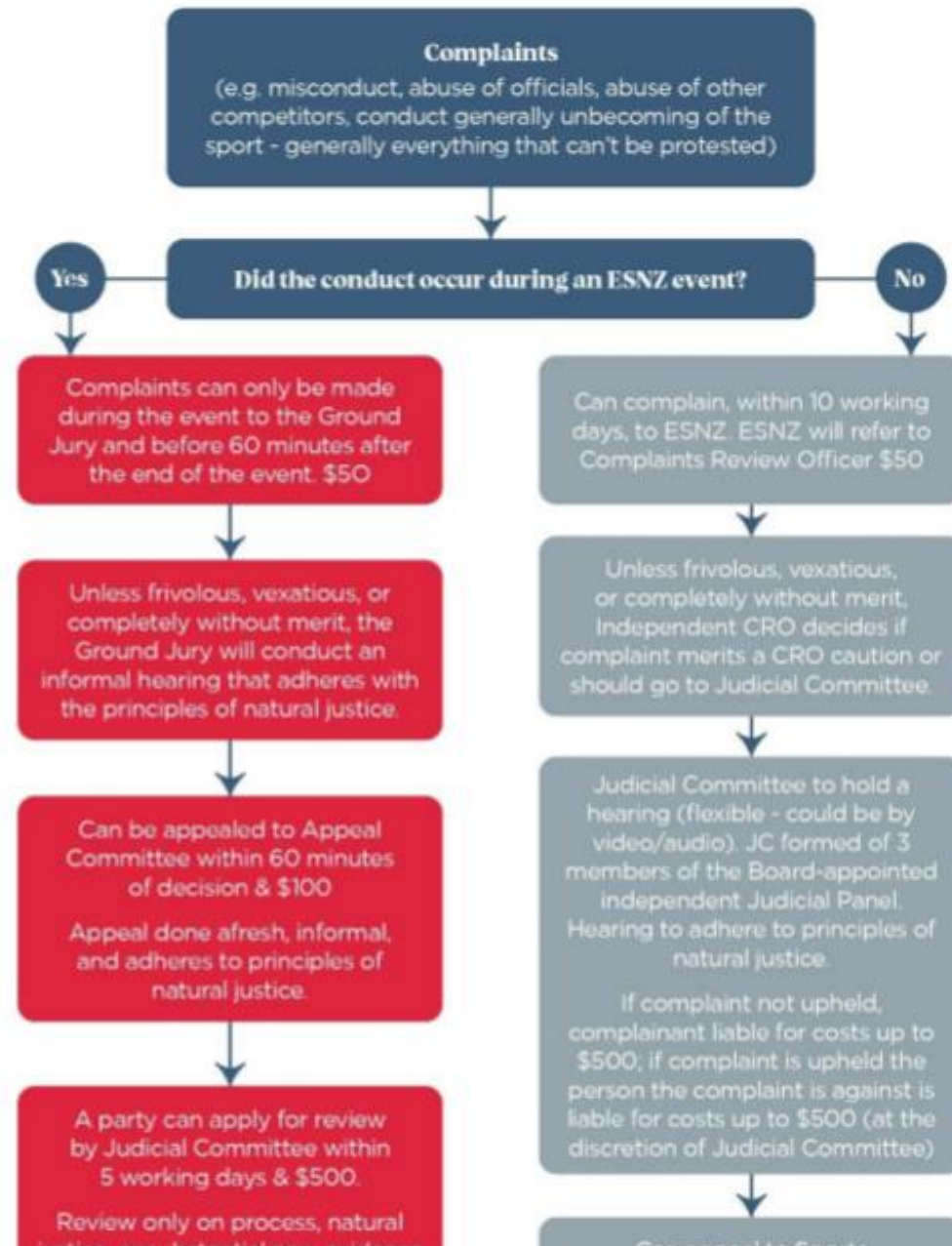
## Complaints:

If the conduct occurred during the event on the day, should be advised to the Gound Jury, must be no later than 60mins after completion of event, \$50 lodgement fee.

If the conduct is generally not related to the competition, can complain to ESNZ within 10 working days, \$50 lodgement fee

# INSURANCE - Public Liability

ESNZ has an insurance policy with AON which covers the activities of the national organisation, its officials, members and disciplines. The cover provided is as follows:

## **Public Liability**

- ❑ Cover against your Legal liability against claims for compensation in respect of unexpected and unintended personal injury or property damage arising out of their business activities within New Zealand only.
- ▶ **Business Activities**  
Equestrian Events
- ▶ **Sum Insured**  
\$10,000,000
- ▶ **Extensions**  
Forest & Rural Fires Act – \$1,000,000
- ▶ **Excess**  
\$1,000 each and every claim (with excess to be paid by the area group/club or OC)

# INSURANCE - Statutory Liability

## Statutory Liability

- ❑ Statutory Liability Insurance is designed to provide cover to the society and its trustees, officers and employees for defence costs and fines/penalties\* in respect of unintentional breaches of almost all Acts of New Zealand Parliament, with the exception of the Health & Safety at Work Act where the policy covers defence costs and reparation orders (this Act expressly prohibits insurance for fines and penalties).

\* No cover is provided in respect of civil proceedings (defence costs or civil penalties (pecuniary penalties)).  
Note, depending on the circumstances and subject to policy terms and conditions cover may apply to official investigations.

- ▶ **Business Activities**  
Equestrian Events

- ▶ **Sum Insured**  
\$1,000,000 per event

- ▶ **Excess**  
\$500 each and every claim (with excess to be paid by the area group/club or OC)

# INSURANCE – who is covered

## ➤ *Who is covered by the ESNZ policy?*

- **All members** are covered by the ESNZ policy for actions at an ESNZ event or within ESNZ equestrian activities such as competing at shows and organising/undertaking equestrian.
- **All ESNZ registered officials who are current full financial members** are covered by this policy at all times when they are officiating.
- If you are an ESNZ area group or affiliated club in the case of Endurance, then you are automatically covered by this policy for equestrian events.
- *The liability policy only covers Equestrian Sport NZ as the governing body, however, has been endorsed to cover members of ESNZ in regards to their exposure to Public Liability and Statutory Liability when running/competing in Equestrian Sport Sanction events.*

## ➤ *Who is not covered?*

- **Area groups that are incorporated societies are not covered events.** If your group is an incorporated society, please contact Danielle at AON [danielle.rose@aon.com](mailto:danielle.rose@aon.com)
- Your group is not covered if it is an independent group that is not part of the ESNZ structure (ie: you are not an area group or affiliated club, you might be a sports club or a group of people keen to hold some events).



# INSURANCE - Obligations

- You need to ensure you are complying with the ESNZ general regulations and your own discipline rules. This includes having a current membership.
  - You need to ensure you have a clear health and safety plan and that you have used the checklists on the ESNZ website to ensure you have covered all the areas we would expect to be covered.
  - You need to appoint a Health and Safety officer for your event.
  - You need to take all precautions to ensure everyone goes home safely.

# AFFILIATION FOR NON-ESNZ AREA EVENTS (ASSOCIATED EVENTS)

- Associated events may use ESNZ rules and regulations. This includes the Judicial System, however any costs will be payable by the Organising Committee of the event.
  - Rules cannot be “part” used. They must be used in their entirety including registration and levy payments as per the discipline / ESNZ rules.
  - Support is available for secretaries by using either of the online entry providers or by discussing with the Discipline Sport Manager.
  - Insurance cover can be purchased for your event from ESNZ. This will cover your event for Public Liability and Statutory Liability of \$10m and \$1m respectively.
  - Associated events must adhere to all Health and Safety guidelines.
  - All riders at these events must wear tagged safety helmets at all times when on a horse.
- 
1. Affiliated Events paying on a per event basis:
    - One day = \$60 or \$260 with insurance.
    - Two days = \$100 or \$300 with insurance.
  2. Member Organisations (fee annually):
    - \$500 without insurance or \$700 with insurance

- List of all the competitors with contact details and summary of monies paid or balances outstanding
- Full set of results
- All income and expenses in summary as well as detail with copies of invoices associated
- List of all payments received and expenses paid linked to competitors and suppliers
- List of all officials, judges and technical persons involved in the show
- Entry statistics for all classes
- Profit and loss statements
- Recommendations and check list from the show for the next show/secretary

# AREAS CHECKLIST

- Organising Committees must abide by all Equestrian Sports NZ General Rules and Regulations and the rules for Jumping
- Affiliation letters are available to support Areas in Grant applications.
