Article 153: Minimum Standards for Medical Personnel and Services at ESNZ Events

- 1. The Organising Committee Prior to any ESNZ event
- Must appoint a Medical Co-Ordinator who will be responsible for ensuring the medical arrangements for the Event meet both ESNZ General Regulations and any Discipline Rules with regards to medical standards.
- The Medical Co-Ordinator must undertake a risk management analysis (taking into account the level of emergency services available in the area and the distance and travel time to and from the event to reach those medical services to ascertain whether a level of medical cover above the minimum standard should be provided at the event).
- Identified the number and location for First Aid/Treatment Centre/s needed for the event which will depend upon the layout and size of the event location and the potential number of people attending the event including competitor and their support people plus spectators.
 - First Aid/ Treatment Centre/s which must be private and ideally quiet where first aid or further medical support can be received (see Annex J)
 - There must be rapid access to and from the First Aid/Treatment Centre/s to all areas of the Event for an ambulance or Rapid Response Vehicle. The access routes must remain free and unblocked throughout the event.
 - First Aid/Treatment Centre/s must be provided with good communication resources including access to radio communication with officials and phone/mobile communication with Emergency Services
- The Medical Co-ordinator must notify local after-hours Emergency services of the event dates and potential injuries seen at equestrian events.
- Must have an agreement in place with the venue/property owner as to who
 is responsible in case of emergency before the event begins and after it
 finishes.

An event cannot start without the necessary medical standards in place.

- 2. The minimum standard of medical personnel and resources that must be provided on-site during a Dressage/Para-Dressage event are as follow:
- Minimum medical personnel on-site during the hours of competition and located at the first aid/ medical centre/s are
 - a First Aider or First Responder (see Annexes J and K) for Events with up to 120 riders
 - Emergency Medical Technician plus a First Aider or First Responder (see Annexes J and K) for Events with over 120 riders and

- Minimum medical resources on-site during the hours of competition and located at the first aid/ treatment centre/s are:
 - a fully equipped EMT Kit, or First Aid Kit conforming to the requirements of a Workplace First Aid Kit as defined by Worksafe's Good Practice Guide. (https://worksafe.govt.nz/managing-health-and-safety/businesses/general-requirements-for-workplaces/) (see Annex J)
 - o rapid response vehicle (see Annex J). If a fully equipped ambulance is provided this can function as the event's First Aid/Medical Centre.

3. The minimum standards of medical personnel and resource that must be provided on-site during an Endurance/CTR event are as follows:

- Minimum medical personnel on-site during the hours of competition and located at the first aid/medical centre/s are
 - a First Aider or First Responder (see Annexes J and K) for Events with up to 50 riders per day
 - at least two First Aiders or First Responders (see Annexes J and K) for Events with over 50 riders per day
- Minimum medical resources on-site during the hours of competition and located at the first aid/medical centre/s are:
 - a fully equipped First Aid Kit per First Aider/First Responder conforming to the requirements of a Workplace First Aid Kit as defined by Worksafe's Good Practice Guide. (https://worksafe.govt.nz/managing-health-and-safety/businesses/general-requirements-for-workplaces/) (see Annex J)
 - o rapid response vehicle (see Annex J). If a fully equipped ambulance is provided this can function as the event's First Aid/ Medical Centre.

4. The minimum standards of medical personnel and resource that must be provided on-site during an Eventing event are as follows:

- During the Dressage and Jumping phases an Emergency Medical Technician plus additional personnel with at least first aid certificate as set out within the ESNZ Eventing Rules (Article 635 and Annex 4) and in Annexes J and K below.
- During the cross-country phase the minimum standards of medical personnel and resources are as set out within the ESNZ Eventing Rules (Article 635 and Annex 4) and in Annexes J and K below.

5. The minimum standard of medical personnel and resources that must be provided on-site during a Jumping/Show Hunter event are as follow:

- Minimum medical personnel on-site during the hours of competition and located at the first aid/medical centre/s are
 - a First Aider or First Responder (see Annexes J and K) for Events with up to 100 riders
 - Emergency Medical Technician plus a First Aider or First Responder (see Annexes J and K) for Events with over 100 riders and

- Minimum medical resources on-site during the hours of competition and located at the first aid/ treatment centre/s are:
 - a fully equipped EMT Kit, or First Aid Kit conforming to the requirements of a Workplace First Aid Kit as defined by Worksafe's Good Practice Guide. (https://worksafe.govt.nz/managing-health-and-safety/businesses/general-requirements-for-workplaces/) (see Annex J)
 - o rapid response vehicle (see Annex J). If a fully equipped ambulance is provided this can function as the event's First Aid/ Medical Centre.

All events must also comply with discipline safety and medical rules as set out in the discipline rules.
