Chief Executive Report 2023

The last year, in many cases, bought us some type of normality with regards to the delivery of competitions across the country. This allowed us to start to drive the implementation of our new strategic direction and put in place the foundations for the ongoing work required to meet our strategic outcomes in Community, Competitions and High Performance.

The year was filled with some highlights along with a few setbacks. Firstly, our Eventing team returned to the Podium at the World Champs in Pratoni, Italy with a team and individual bronze. These were our first medals in 12 years, which also secured us a ticket to Paris. We were also thrilled to have a Dressage team at Herning for the World Championships. While we did not qualify for Paris, the performances and the experience the team had will be invaluable moving forward.

We also saw the cancellation of the Horse of the Year show for a third consecutive year due to the region being devasted by tropical cyclones in the weeks leading up to the event. Many of our members were affected directly and there were some horrific scenes coming out of the region. They say when times are tough people come together, and we were humbled by the response of the New Zealand public to our Cyclone Relief fund which raised over \$200,000 that was put back into the community via a grants process. While we could not cover everyone's costs, we hope that in some way we were able to help many equestrians across the region. We should also note here and thank the FEI who made a staggering \$57,400 contribution to the fund.

We must also thank again all of the officials and volunteers and the supporting partners, mums, dads, caregivers and whanau who are the backbone of our sport. Without you the show simply does not go on.

Partnerships

The year saw the introduction of Land Rover as our premier partner. The relationship included support through to the Disciplines and the supply of two vehicles to help promote the Land Rover family of cars. There were also several events where Land Rover was present on site with staff and vehicles. We look forward to the ongoing development of this key relationship and thank Steve Kenchington and Luke Meurant for their support.

Sport New Zealand support continued to fund some agreed initiatives focused on youth, coaching, inclusion and our Change the Rein campaign. We were also able to secure new funding for the Strengthen and Adapt programme over a three-year period. A fantastic outcome after a significant amount of work.

High Performance Sport New Zealand funding was secured for Eventing through to Paris. Our result at Pratoni helped bring some extra funding back into our eventing system as well.

Our Jumping program continues to have fantastic support from the Plaw Family. This support, along with the world class facility at Takapoto, are helping provide amazing opportunities for our members at all levels.

To our national partners IRT, Majestic Horse Floats, and Petcover Equine we thank you for your ongoing support, and to the supporters and sponsors at Discipline level, your support is critical in enabling us to provide great experiences for our riders.

Schools Competition

The inaugural Secondary Schools competition was held in winter school tournament week and was a huge success. Run in conjunction with New Zealand Pony Clubs Association and the Secondary Schools Sports Council, school teams from all over the country ascended on NEC Taupō and NEC Christchurch with a focus on Participation, Fun and Teams. Students had the chance to compete across multiple disciplines including CTR, Jumping, Dressage and Arena Eventing. Added to the program were off-horse events around animal nutrition and a presentation from Drug Free Sport.

A huge thanks to the parents, students, volunteers and the ESNZ Team who helped make the week such a success.

We look forward to developing this tournament week further and continuing to evolve the competition with input from the schools and the students.

Finances

The overall result for the year was a group surplus of \$23,045 with a resulting total equity position of \$6,809,085.

ESNZ's consolidated annual surplus of \$23,045 represented an 86% drop from the previous financial year. Total revenue increased by 31% on last financial year and this improvement was achieved equally across the grants

and sponsorship funding and the operational revenue (from service delivery). Notably tours and events revenue has more than doubled from \$308K to \$705K.

Expenditure increased overall by 35% with increases being seen in employee related costs (33%) and high-performance related costs (4%), operating lease costs (12%), and merchandising costs (37%). Other operating costs increased by 70% mainly through competition and event expenses (87%), legal expenses (203%), administration expenses (261%), and prize money (110%). With additional funding provided by Sport New Zealand during the year, ESNZ was able to engage specialist knowledge to develop future initiatives, resulting in the increase in administrative costs.

Cash generated from operations during the year was a contribution of \$237,161 with investing activities being a

net outflow of \$534,858 and cash utilised in borrowing activities of \$117,670. This resulted in a utilisation of cash resources of \$415,367 since June 2022. It should be noted that 86% (\$2.8m) of these funds are controlled by the various disciplines.

Central incurred a current year surplus of \$15,980. This is a decrease of \$18,305 from the prior year and is largely due to accommodation and travel (95%), advertising and promotion (280%), and salaries (34%) through the growth of the team to enhance the delivery of the strategy. An increase in sponsorship (409%), equine registrations (5%), product sales (43%), and government funding (56%), with savings in IT consultancy and support (28%), recruitment (60%), and depreciation (74%) positively impacted the surplus for the year.

Below are the financial results for the different cost centres within the consolidated accounts and the results for the past five years.

Looking Forward

The year ahead looks busy as we really start to push on with some key projects around pathways for riders, officials, and coaching.

We will also see the delivery of a National Facilities strategy that is being done in conjunction with New Zealand Pony Clubs Association.

We look forward to the return of the Land Rover Horse of the Year after a three-year hiatus.

The Constitution review will come to an end with a goal of adoption at the AGA.

We will deliver our second National Secondary School Championships in the winter tournament week at NEC Taupō and NEC Christchurch. We are expecting real growth in this event in year two.

We will continue our work in the Strengthen and Adapt project with completion of a nationwide Roadshow across eleven centres.

In the High Performance arena, we will be aiming to get an individual qualified in Dressage and Jumping. We will also see the continued development of the HP system to include Endurance and Para-Equestrian.

Finally, I must make mention that our sport is potentially entering a tipping point with regards to our Social License to Operate. The wellbeing of our Horse and Human is vital to us and, more now than ever, we will come under a public microscope as to how we treat our horses. This is a collective responsibility to show the 'Good Life of the Horse' and is an area we are focused on developing alongside many equine partners across the country. We will need to come together as a sector and support each other in agreeing what we want the life of the horse to look like and then promote this widely across the country.

Another busy and exciting year ahead.

National Equestrian Centres

National Equestrian Centre Christchurch

NEC Christchurch has had another busy year with significant improvements and developments underway. It is important to recognise that the NEC caters for all disciplines and the NEC committee operates with extremely good cooperation across them.

As many of you will appreciate, we host activities from training days through to FEI events, and national championships.

All of the local disciplines have strong active committees that are always doing things, and of course requesting improvements to enhance not only their sport, but also the Centre as a whole.

The key developments during the year have been:

- The commissioning of the new water jump at Springston Trophy.
- The installation of some new ditch jumps in conjunction with Springston Trophy.
- The stone burying, contour / levelling and re-grassing 13ha of the training ground. This will make a massive difference as to how the grounds can be used.
- Development of a large new all-weather arena which can be used for training and competition.
- The commencement of work on some new covered yards.
- The commissioning of Onsiteas an app-based Health and Safety monitoring and reporting system.
- Development of a Memorial Rose Garden to commemorate those who have contributed to the NEC over the years.
- Purchase of a ride-on mower more suited to some areas than the tractor mounted options.
- Installing (and now replacing due to somebody thinking it would be better suited in their own home) a large screen television and meeting camera system.

The NEC is lucky to have a committed and dedicated committee, who turn up as regularly as they can to the various meetings and contribute outside the meetings where they can as well. Everybody has their specific discipline, and it is great to get the cooperation across disciplines to further develop the facility.

NEC has identified an ongoing development plan and these items will be a focus going forward.




We are lucky to have dedicated hard working committee volunteers and staff that have the NEC at heart, and we thank them for all of their work.



Board Chair Report 2022-2023

Equestrian Sports New Zealand (ESNZ) exists for the equestrian community to participate in organised, safe and inspiring recreational and competitive equestrian sport experiences.

With new Board members and a new General Manager of Community, it was valuable for ESNZ Board and senior management to come together face-to-face in November 2022 to review priority focus areas for 2023. They were also able to ensure ESNZ remained focussed on delivering the strategic outcomes and the best experiences for members.

Whilst the competition landscape appeared to settle back into some sort of rhythm as competitions resumed unimpeded by COVID, it was short lived, as many areas of the North Island were seriously impacted by Cyclone Hale and Cyclone Gabrielle. To the equestrian community who were affected, ESNZ acknowledges your loss. ESNZ also acknowledges the work of the Disciplines, area groups and organising committees who, throughout their season, had many competitions interrupted by bad weather, and re-scheduling in an already busy calendar was problematic.

A highlight this past year was the Eventing team's podium finish at the World Championships in Pratoni, Italy and also to Tim Price on his bronze medal performance. An awesome result! It was also a real celebration to have a Dressage team at the World Championships in Herning.

Constitution Review

The work on ESNZ's new Constitution continued this past year. Consultation with the Disciplines and members, continued input from the working party, Barrister Mark von Dadelszen and management have all helped frame up the document we have in front of us now. The focus has been on having this ready for adoption at the AGA September 2023. The Incorporated Societies Act 2022 (the new Act) was passed on 5 April 2022 and ESNZ can apply for reregistration from 5th October 2023.

Membership Online Services

ESNZ is committed to providing a good on-line (digital) experience for members. This remained a focus for the year, and it has been rewarding to hear of the positive on-line member experiences as members register themselves and their horses. The full launch of the competition results capability of the database took longer than anticipated, in order to deliver what was required. The Board acknowledges the relentless efforts of management to deliver quality results for users.

The Board received the findings of the recent IT review and is looking towards investing in this going forward. ESNZ acknowledges the support of Sport NZ with the review.

Facilities

The work that has commenced as part of the National Facilities review in collaboration with New Zealand Pony Clubs Association, is very timely. Access to quality facilities for a relatively small population that covers a huge geographical region presents an opportunity to be strategic in their placement and development.

Thank you to the National Equestrian Centre (Taupō and Christchurch) convenors and committees. The dedication of this group of volunteers is appreciated and the fruits of your labour are very visible.

ESNZ would like to make special mention and acknowledgment of Taupō Convenor, Wallie Neiderer as he steps down from the role of convenor. Over the past 15 years, Wallie has given so much of himself to the Centre. Wallie's passion, commitment, hard work, and a no fuss - get on with it attitude - have seen an enormous development at the Taupō NEC. Thank you Wallie.

Strengthen and Adapt

The Board has been enthusiastic about the launch of Strengthen and Adapt, a three-year project funded by Sport NZ. This is an opportunity for the equestrian community to co-design equestrian activity and sport, so it is fit for purpose for our current and future landscape. Great to see this underway.

ESNZ appreciates the support from Sport NZ for their investment in this and numerous other ESNZ projects.

Horse of the Year

Sadly, the Land Rover Horse of the Year 2023 event was unable to proceed. ESNZ is a shareholder of Horse of the Year Limited (HOYL). Richard Sunderland resigned after many years of service as an ESNZ representative on the HOYL Board. We express our sincere gratitude to Richard for his time on the Board.

The focus is now looking forward to 2024 and beyond, and ensuring an exciting future for this world class event.

Board

This year we welcomed Lisa Marcroft, an appointed Board member to the ESNZ Board. Lisa brings strong business and commercialisation experience, and a deep understanding of equestrian.

There was also some change to the Discipline representatives with new members Penny Tapley (Show Jumping), Marg Evans (Eventing) and Sarah Hazlewood (Dressage) joining the Board.



High Performance Report 2022-23

It has been a year of excitement for High Performance which has seen us win World Championship medals for Eventing, the first in 12 years, the continued growth of the Jumping High Performance Programme and the introduction of the new Dressage High Performance Programme.

We now have established and funded High Performance programmes in all three Olympic Disciplines which is a direct outcome of the Whole of Sport High Performance Strategy developed in 2021. Funding of all the programmes continues to be front of mind as we work to make all programmes sustainable.

The inaugural High Performance Off-Horse Camp, combining all discipline squads, was held in May in Hastings at the Sports Park. The off-horse camp focuses on learning away from the horse and attendees engaged in team building activities, resilience exercises, educational sessions – communication, ESNZ structure and High Performance Programme details – and hear from guest speakers highlighting – 'what it takes to get to the top' and 'how to deal with challenges in sport' from each other. This whole of sport camp was very well received and something we will continue to run annually.

There has been an update to the High Performance structure this year as well, as with now having three functional programmes running, the administration demands have grown. As a result, Eliza Johns (former Eventing Sport Manager) joined HP General Manager Jonathan Paget and HP Operations Manager Warrick Allan in forming High Performance Central, who are responsible for the overall strategic direction and running of the HP programmes along with reporting and continued relationships to stake holders and discipline boards.

Eventing

The Eventing programme delivered a successful campaign to the 2022 FEI Eventing World Championships in Pratoni in winning both Team and Individual (Tim Price) Bronze medals, the first medals for New Zealand at a championship since 2012 and a welcomed boost for the programme. This performance for the Team also secured New Zealand a qualification for the Paris Olympics in 2024 and signalled that the strength and depth of the programme are moving in the right direction.

Tim and Jonelle Price finished the 2022 Eventing Year, which concluded in October in the Northern Hemisphere, as World no.1 and no.2 in the FEI world athlete rankings, a position they held for the first half of 2023. And shortly after, they were members of the successful Nations Cup

team that placed second in the CCIO4*-L at Military Boekelo in the Netherlands. A fantastic conclusion to the season for the UK programme. Team Price groom, Kerryn Edmans was one of four international grooms nominated for the Cavalor FEI Best Groom category at the 2022 FEI Awards and was selected as the overall winner.

Lizzie Green was appointed to lead the NZ based programme at the start of January 2023, replacing Penny Pearce who departed to lead the Dressage programme. Jonathan Paget continues to lead the UK programme, performing a dual role as General Manager of High Performance.

The New Zealand programme continues to strengthen and grow depths in the squad system, ensuring we have talent coming through the pathway. Some highlights of this year have been the Cross-Country camp, which was held in February 2023, where course builders, Chris Ross and Tich Massey built some technical lines at a 2* height to get riders and horses in tune and feeling prepared and ahead in their preparations for the season. The return of Isobel Wessels to New Zealand was another highlight. The collaboration between Dressage and Eventing brought Isobel to our shores for a series of clinics and training days to work with riders, coaches and judges, ensuring that we keep up with international trends and standards. It was great to see the coaching and judges workshops so well attended.

Dressage

Reflecting on the 2022 - 2023 year within the Dressage High Performance programme and there is plenty to celebrate, most notably that New Zealand fielded a team (Melissa Galloway - Windermere J'Obei W, Gaylene Lennard - Jax Johnson, John Thompson - Chemistry) at the 2022 FEI Dressage World Championships, for the first time since 1998. Unfortunately, we were unsuccessful in obtaining team qualification for the Paris Olympics so now look forward to individual campaigns for Paris 2024 and focussing on the next World Championships.

Without dedicated funding it had been difficult to launch and deliver on a full dressage performance programme. However, a commitment was agreed between ESNZ and ESNZ Dressage to fund an end-to- end performance pathway. This funding enabled the appointment of a dedicated HP Dressage Manager, Penny Pearce, in January 2023. Penny quickly got to work and redesigned the dressage performance pathway for all squads and completed a selection review in February 2023.

The forward momentum made in the HP Dressage space in the last 12 months remains with high performance athletes continuing to campaign for individual quota spots in Paris next year along with the national High Performance programme taking shape quickly.

Jumping

The main target for the campaign side of the High Performance programme for the past 12 months has been to have a team ready to participate in the Group G Olympic Qualifier at Valkenswaard on 18th July 2023 to secure New Zealand a team spot in the Jumping at Paris 2024. To achieve this, the team must finish in either 1st or 2nd place in the qualifier against the other nations present. Engaging with the core group of athletes most likely to be selected for this competition, has been the focus, to ensure that they arrive at the qualifier as best prepared as possible and has included supporting their individual training programmes for the first half of 2023.

Now almost 24 months since the introduction of the revised Jumping performance programme and the embedding of new relationships and processes has produced some pleasing results. Australian coach Michelle Strapp visited New Zealand three times within the 2022-2023 season for three different squad camp dates across various north island and south island locations as well as attending the nationals at McLeans

Island. The squad camps continue to evolve and grow as the programme responds to both coach and athlete feedback. With everyone together, squad camps are the ideal opportunity to include additional education which varies from horse health, athlete wellbeing and cross discipline activities.

Oliver Edgecombe continues to lead the programme and has attended many key competitions across the calendar as well as the squad camps.

Para-Dressage

With the introduction of the new Para-Dressage Sport Manager, some initial rebuilding work in the Para space has begun. Paris Paralympic Games is a championship event available to NZL Athletes, though the first step in this process is securing NZL an individual spot at the Games.

Endurance

Discussions have recently started with Endurance to rebuild their High Performance Pathway to provide opportunities for Athletes wishing to aim for the next World Championships. The next piece of work is to review what has been done previously along with looking at what is the best approach to gain international success, given the limitations in NZL and the ever-increasing international standard in Endurance.

Jumping and Show Hunter Report 2022-23

This is my very last report as Chair of ESNZ Jumping. After a total of six years as Chair, and a total of 10 years on the Board, I am stepping aside and welcome Penny Tapley into the role for the coming year.

After two years of dealing with the dramas of COVID-19, whoever would have thought we would have even more challenges placed on the Board and many organising committees with the extremely wet weather, especially in the North Island. Just as we approached our first Land Rover Horse of the Year Show in three years, we had a massive cyclone annihilate the East Coast of the North Island weeks out from the show. Once again, the only answer was to cancel our pinnacle show of the season. Next year......let's hope!

World Cup Final

On a positive note, Phillip Steiner and his fabulous mare Cassina Dior, a.k.a. Dolly, did us proud on the world stage at the World Cup Jumping Final in Omaha against the best of the best. The only option to get Dolly to Omaha was to land in Europe and restart her trip from there. No other horse travelled anything close to that distance and to see her at the final, firing on all cylinders, was simply fantastic. What a stunning mare.

Phillip has returned to Europe and has been confirmed in the New Zealand team at Valkenswaard, aiming to qualify our Jumping team for the forthcoming Paris Olympics later in July. This is tougher than last time (pre-Tokyo) with both the Japanese and the Australians back in the Group Eight pool also hoping to qualify. New Zealand needs to place in the top two to qualify a team for Paris. Other team members are Daniel Meech and Donjon D'Asschaut, Richard Gardner and Calisto 5, Tom Tarver and Fiber Fresh Popeye, with the Reserve being Samantha McIntosh and Hagrano PMS.

FEI

Back home here in New Zealand, after three years in a holding pattern with the difficulties of international travel, upgrading any of our FEI officials has been an impossibility. Slowly there has been some restoration to normality. We have had an FEI Steward's course in Hastings this season, and we are sending our FEI Level 1 Course Designers to Australia for an upgrade course in July, with a planned FEI Course Designers' Refresher (maintenance) course in New Zealand next year. We are in communication with our Australian counterparts to work towards upgrade and maintenance courses for our FEI Judges.

Currently, to comply with FEI requirements we are need nearly every FEI Judge and Steward at every World Cup class we run. The cost of compliance per round is significant to both ESNZ Jumping and the host committee. We need to ensure we do not completely burn these people out and hence for the last two years the Jumping board has chosen to hold a total of only five rounds.

In spite of the weather that didn't help us out on any occasion, we saw some super jumping in the World Cup classes with some seriously polished rounds resulting in a significant number of combinations acquiring MERs which will contribute toward Olympic Games eligibility.

Performance/High Performance

ESNZ Jumping will be forever grateful for the opportunities the Plaw family have created toward the Jumping Performance Programme. Not only are we grateful for the significant financial contribution they have made toward the programme but also the opportunity to use their fabulous Takapoto Estate for training, and the contacts with other sports HP programmes drawing on some skilled people from the greater Waikato Area.

The Performance programme is in a very exciting phase and the riders involved are reaping the rewards from the multi-faceted holistic approach.

Series Sponsors

This year we had a full quota of sponsors across the board for both Jumping and Show Hunter. As I repeatedly say on an annual basis, our sponsors are vitally important to our sport as they contribute to the overall running cost, and as a result, benefiting every last person who competes in Jumping. The series also provide interest across the board to multiple levels of riders and horses, especially as the season draws to a close. It has always carried significant prestige to win any series, requiring repeated outstanding results. You don't win a series by mistake!

Officials

We are also forever indebted to our many Officials who turn up week in and week out to allow our events to run. Thank goodness they all do it because they genuinely love participating in our sport. Without them there simply would be no sport.

A specific thank you to all of the people on our Technical/ FEI Committee who are called on regularly for meetings via zoom, as well as attending the annual two-day meeting at the completion of each season.

My very best lifelong friends are pretty much all involved in the sport. It's a pretty good place to be, at a Jumping show, but best when the sun is shining! Let's hope it does that next season. I thank you all for the support in my role as Jumping Chair, and welcome Penny Tapley as she takes over the leadership reins.

Dressage Report 2022-23

It has once again been an exciting and challenging year for Dressage. Just when we thought that the days of big events and show calendars being upended at short notice were behind us, we had yet another crisis to deal with, this time in the form of a Cyclone. The way our community came together to support our members who were affected by the Cyclone was a real focal point of the year, highlighting so much compassion and generosity.

The work that was done to get Dressage events back up and running and to continue to offer a CDI 3* for our Paris hopefuls - despite the cancellation of the Horse of the Year show - was tremendous. A huge debt of gratitude must be expressed from me on behalf of the Dressage community to the Dressage Waikato organising committee (with a particular thanks to event manager Angela Nobilo) who accommodated the CDI at the Waikato Championships, moving mountains to make this happen.

This year has seen some exciting developments that promise to benefit all sectors of our sport. At the High Performance level, we had the restructure of how our Performance Programme is delivered. Our performance programme is now managed by the High Performance team which includes a dedicated high performance manager for Dressage. Penny Pearce who was appointed to that role, and despite finding her property under water shortly after her appointment, has hit the ground running.

This restructure will ensure that we can provide our best riders with the support that they need to entrench New Zealand as a real player in international Dressage.

The move of the performance programme to High Performance has permitted the Performance committee to evolve into the development committee focused on delivering development opportunities for all riders. This committee has been working hard and is well on track to deliver the Julie Brougham adult development camps in the both the North and South Islands.

The Land Rover Dressage Teams League has been another exciting addition to the calendar this year. A league competition such as this puts a large amount of administrative burden on those who have to keep track of the scores over the season, and a huge thanks must go to Jos Gresham who managed this points workload. It has been exciting to see that we have been able to make progress in a way that is benefitting riders from the grass roots right through to our international performers.

Eventing Report 2022-23

The Eventing year has delighted us with many achievements by our riders and horses, our officials and our community giving us plenty to be proud of and to be inspired by.

Organising Committees, our Officials and the extraordinary weather challenges

With the country coming to grips with the devastation of the extreme weather events, the predictability of pre COVID times seemed a very distant memory. New Zealanders' response to the grim realities of the aftermath has been heart-warming. I'd like to acknowledge those affected by the flooding and the devastation it caused, the losses of their beloved equines, property and belongings, and offer the Eventing community's heartfelt condolences. Thank you to all of you who have contributed to the ESNZ Equine Relief Fund. The Brookby Horse Trial fundraiser event was a tremendous success raising \$34,000 for the fund. What tremendous generosity from the Eventing Community!

With wet weather having an impact on events during both the spring and autumn seasons, the riders were very appreciative of the opportunity to get out and compete and are very grateful to those OCs for making Events happen. Springbush OC relocating their event to Taupō at very short notice was an incredible achievement and was greatly appreciated.

I'd like to acknowledge our Officials and Organising Committees who faced a number of really difficult decisions under time constraints of whether to cancel, postpone, change XC jumps etc. With the safety and welfare of both rider and horse at stake, these decisions are weighty and not taken lightly. So, I thank you for your considered and often late night, early morning deliberations and making these decisions on behalf of the sport.

Many successes to celebrate

Young Rider Team Wins Oceania Championship June 2022 - at the Melbourne International Three-Day Event, Werribee, Australia: Charlotte Treneary (CHS Royal Genie), Charlotte Penny (Festival), Mackenzie Marlo (CHS Diplomat) and Brittany Fowler (Game Keeper), Chef d'Equipe: Lizzie Green. Central to the team's win was the outstanding performance of Charlotte Penny who won the CCl3*L class, finishing on her dressage score at her first 3*L.

Bronze x2 at the FEI World Eventing Championships August 2022 - After a 12-year WEC medal drought, it was great for the New Zealand team to win individual bronze and team bronze at Pratoni Italy. This achievement was recognised with a nomination for Team of the Year at the ISPS Handa Halberg Awards. Congratulations to Tim Price (Falco) individual bronze and fellow team members Jonelle Price (McClaren), Monica Spencer (Artist), Clarke Johnstone (Menlo Park), Chef d'Equipe Jock Paget, their grooms, owners, connections and the whole New Zealand team.

Providing inspiration to many was Monica Spencer's campaign from New Zealand. It's testament that the HP programme in the northern and southern hemispheres are well aligned, and it is indeed possible to compete on the world stage while being based in New Zealand.

Double Podium finishes at the Boekelo Nations Cup October 2022 - Tim Price won the CCI4*-L at Boekelo and steered the New Zealand team to second in the FEI Nations Cup. The team included Dan Jocelyn (Blackthorn Cruise), Jonelle Price (Killbunny Andy), and Amanda Pottinger (Good Timing). The Kiwis had a fabulous win at the Millstreet Nations Cup Event recently but that technically falls into next year's report!

Kiwi Eventers claim World #1 and #2 spots - With a long list of achievements, you can see why - in October - the FEI rankings placed Tim Price at no.1 and Jonelle Price at no.2. It is believed they are the first married couple to do so. Ten months later Tim still holds the no.1 ranking. What a great achievement for Tim and Jonelle, our small country and for the 'village' associated with these two. Quite appropriately Tim was named Rider of the Year at the ESNZ Hall of Fame awards.

Kiwi Groom wins at FEI Awards - Team Price's groom, Kerryn Edmans (Hanmer Springs), won the Cavalor FEI Best Groom category at the 2022 FEI Awards, which covered all disciplines and not just Eventing.

Matthew Grayling and Trudeau made history at NZODE & NZ3DE - In 2023, Matthew and Trudeau set a new record of five consecutive 4* National titles: NZ3DE '21, '22, '23, and NZODE '22, '23. Trudeau is a 16-year-old NZ Warmblood owned by Winky Foley and Peter W. Smith. Congratulations to them and to Matthew for breeding and producing such a consistent winner. Trudeau was recognised at the ESNZ Hall of Fame awards as joint winner of the National Horse of the Year.

ESNZ Eventing Officials pathway achieved FEI Equivalency - In 2022, FEI Eventing revised its Eventing Education System and our Technical Advisory Committee worked very hard to achieve Equivalency for New Zealand's Eventing Education System. This means our National List 1 Officials can go straight to Level 2 FEI rather than spending two years at Level 1. Congratulations to those involved in the system and application process.

New Zealand Officials achieve FEI Level Four status – FEI's revision of the Eventing Education System introduced a fourth level of qualification. It wasn't a straight alignment, and it only recognised the most qualified and experienced Level 3 officials who are already fulfilling the Transfer-up requirements to Level 4 under the new Education System. Five New Zealand officials were among only 69 Judges, CDs and TDs listed worldwide who achieved Level 4 FEI Official status. Congratulations to Judges Helen Christie, Stuart Bishell, Andrew Bennie; Technical Delegate Andrew Bowles; and Course Designer Chris Ross.

FEI Eventing Committee - Neil MacKenzie-Hall was elected to the FEI Eventing Committee in November 2022. This is tremendous recognition of his skills, knowledge and standing in the global Eventing community.

Adopting ESNZ's Statement of Strategic Intent (SSI)

With the new SSI (2022-2026) the ESNZ Board requested Discipline Boards adopted a 'one organisation' approach and align their Annual Work Plans with this, rather than developing their own strategic plans. Eventing recognised the need to contextualise the SSI to the specific challenges and opportunities it was facing. Given that the competitive disciplines align with the second pillar of the SSI, Eventing's strategic plan has been replaced with a Quality Experience Framework, which sets out our aspirations for quality horse and human experiences in Eventing, and informs our annual workplan.

Our framework has six key areas: Quality Competitions, Values and Integrity, Achievement, Appreciation, Culture and Community; and is depicted as a wheel as all these aspects contribute to having a quality experience with no one thing in isolation guaranteeing success. Like a wheel, our experience spins well when everything contributes to it, and if one area is not working, the experience is like a 'flat tyre' and doesn't spin quite so well. Our framework can be viewed on the ESNZ website.

New Board structure in place

This year concludes the implementation of the Board restructure, transitioning us from 11 members to seven, aligning all members to a three-year term, and implementing a more robust election process with the intent to make the Board more efficient and effective. The Board now has the following members: one Rider Representative, one Organising Committee Representative, and three Elected and two Appointed Board members. In attendance at Board meetings are the Eventing Sport Manager, Chair of the Technical Advisory Group (TAG), and the CEO of ESNZ.

Recognising our Valuable Volunteers

Area Groups and Organising Committees - Eventing is entirely dependent on volunteers giving freely of their time, energy and knowledge and it is hard to express the depth of gratitude the Board has to everyone involved. The time freely given is often at the expense of time with family, your own riding, and sleep! I sincerely hope your volunteer experiences and the relationships you've developed within the Eventing community provide you with years of enjoyment and a sense of pride and satisfaction in your contribution.

Life memberships - At the ESNZ AGA in September 2022, two of our Eventing community were made honorary Life members for their outstanding services to Eventing: Judy Haskell for her long-standing services as an official and on the Technical Advisory Committee; and Tinks Pottinger for 30+ years of dedicated service to Organising Committees, including hosting the NZODE at Tauherenikau, and coaching riders.

At each AGM it is great to recognise our marvellous volunteers with the Area Volunteer of the Year awards, and this year our two top volunteer awards recipients were: Diane Gilder Volunteer of the Year Award 2023 (McCrostie Memorial Trophy), and Helen Christie Dedication to the Sport Award 2023 (Longest standing volunteer nominated by their Area Group).

Thanks, in Memoriam - The Eventing community is incredibly grateful to the following for their commitment and dedication to the sport: Bob Stringer who gave endless hours to equestrian competitions primarily as a show jump judge, and his huge input into the development of the McLeans NEC and the early competitions; Mike Manning who was an Eventing FEI Technical Delegate and FEI Steward, stewarding at the Sydney Olympics and many International 4* Events across the USA and New Zealand; and Mary Herrick who is remembered warmly for all her years of service to Eventing Wairarapa.

Wealth of skills and voices around the table

Like all Boards ours needs to have the collective skillset and professional competencies required to serve its purpose, whilst also ensuring we have the appropriate perspectives (or 'voices') as part of the Board discussions and decision-making to serve its members. I would like to acknowledge Marg Evans, who concluded three years as Board Chair in 2022, for her leadership through tough times with the impact of COVID. We are fortunate to have Marg with her depth of knowledge as Eventing's ESNZ Board representative; Shannon Galloway, whose

appointed board position came up for rotation, for her very valuable contributions to discussions and sharing of her professional knowledge of sponsorship; and Grant Porter, elected member, for his contributions to the Board. This year we welcomed: Amanda Illston as the Riders' representative with her wealth of experience having ridden both in New Zealand and overseas; elected member John Alexander, whose previous governance experience has shone through; and TAG Chair Wendy Lansdown, with her wealth of technical and governance experiences. I'd also like to thank outgoing TAG Chair Hamish Butler-Gallie for his leadership and ongoing dedication to the sport.

Thanks to our Sport Manager Hayley Daigle – Hayley is Eventing's one paid staff member and her job description is realistically more than one person should be asked to do. On top of that are the challenges of dealing with volunteers and their availability, and being the first point of contact for the entire Eventing community. Her start in the role certainly wasn't a gentle introduction as she was straight into NZ3DE, Oceania, AGM and hosting the first FEI official's seminar post-COVID. She has done this all with unfailing good cheer and professionalism, and she was very highly praised for her organisation of the FEI seminar from the overseas Directors. I have greatly valued Hayley's enthusiasm and hard work, and have enjoyed working with her this year. Eventing is fortunate to have Hayley as our Sports Manager.

Looking forward

With our quality experience framework in place, we look forward to the year ahead working to provide a safe sport, providing opportunities for people to learn and have a sense of achievement, striving to maintain rider affordability and enhancing the financial sustainability for organisers and the sport, and supporting the sport to be fun and enjoyable to all.

Hosting Oceania at HoY - After much anticipation of the return of HoY and their hosting of Eventing's Oceania competition, it was most unfortunate to cancel in the wake of Cyclone Gabrielle. We look forward to the successful hosting of Oceania at next year's HoY show where it will provide the international flavour of laneways and crowds to help prepare our horse and rider combinations for overseas championship events.

2024 Olympic games – With our Olympic qualification secured at the World Eventing Championships, we look forward to supporting the Kiwis as they build up to and ride for the podium at the historic Palace of Versailles.

It has been a privilege to serve as your Chair this year and I thank you for entrusting me with the role. Whether it's the world class successes of our elite riders, or the smile on the 65cm rider's face that ignites your passion for volunteering, officiating or governing our sport, I look forward to working with you over the coming year with our shared passion for Eventing, and contributing to its future.

The last twelve months have been an extremely busy and challenging time for the Board. There have been many changes, not only within our own sport but also within ESNZ that look to be very exciting, and within the country itself.

We have had two resignations and welcomed Louise Holmes and Sue Landis onto the Board. Being on the Board and organising committees is now requiring people with more diverse skills. In saying that, I would also like to take this opportunity to thank all the Board members for all the work and time that has been put in during these last twelve months.

We have moved to using Evo Events for ride entries. Most have worked well with the new system, however, there have been a few issues which was to be expected. EVOEVENTS are running some online seminars to upskill users in August and I urge clubs to get as many members onto these, as there is more than just entries and results that we can make use of.

Having no dedicated Sport Manager has given us a better picture of what our sport needs. We now feel we are ready to investigate and consider different ideas and approaches to these tasks, which are currently undertaken by the Board.

Our two forums this year were well attended particularly in the South Island, and it was good to have feedback from the members. It is always interesting to see how different both forums are from each Island, each with differing views. We look forward to hopefully bringing some of these ideas to the AGM forum, details of which are to be finalised.

The riding season itself was a bit disappointing at times, with quite a few rides being cancelled due to the weather. Weather did have an impact on the North Island Champs causing most of the grass roots riders not to attend. It also made the track conditions hard, so credit is given to those who rode and successfully completed.

However, it was not all doom and gloom weather-wise and both the South Island

Championships and Nationals ran very successfully. Congratulations to our new Island and National Champions and their beautiful horses.

Again this year, Nick Page attended the FEI forum at Lausanne. Unfortunately, this time he did not come back feeling as positive as the year before. The Board had spent considerable time putting together proposed rule changes and we were very disappointed as to how it was received by the FEI and the manner that the forum was run. We have sent a letter to FEI voicing our disappointment.

Hopefully next season will be full of good weather and successful events for all.

Notes to the Financial Statements

CONSOLIDATED SPECIAL PURPOSE FINANCIAL STATEMENTS OF EQUESTRIAN SPORTS NEW ZEALAND INC

For the Year ended 31 May 2023

1. Reporting Entity

The reporting entity is Equestrian Sports New Zealand Incorporated ('ESNZ' or 'the entity') and is domiciled in New Zealand. ESNZ is an incorporated society registered under the Incorporated Societies Act 1908.

ESNZ is a sporting body that acts on behalf of its members who are involved in equestrian sports in New Zealand. Its primary purpose is to encourage more people to regularly participate in ESNZ equestrian competitions and have great experiences.

The financial statements of ESNZ are presented for the year ended 31 May 2023.

These special purpose consolidated financial statements and accompanying notes consolidate the financial results of activities carried out by the following disciplines:

- · ESNZ Central
- ESNZ High Performance
- ESNZ Dressage (Including National Championships
- ESNZ Jumping
- ESNZ Endurance
- ESNZ Eventing (Including National Three Day Event Championships)
- National Equestrian Centre Taupō
- National Equestrian Centre Christchurch

These financial statements were authorised for issue by the Board on 18 September 2023.

2. Statement of Accounting Policies

BASIS OF PREPARATION

The special purpose consolidated financial statements of ESNZ have been prepared based on a special purpose framework and therefore do not comply with generally accepted accounting practice in New Zealand ('NZ GAAP'). The special purpose financial statements are prepared in accordance with the accounting policies disclosed below.

The preparation of the financial statements serves to report the aggregated financial performance and position to the members of those ESNZ disciplines outlined in note 1 and therefore may not be suitable for another purpose.

MEASUREMENT BASIS

The financial statements are presented in New Zealand dollars (NZ\$) and all values are rounded to the nearest NZ\$.

The financial statements have been prepared on the historical cost basis, unless otherwise stated. Historical cost is generally based on the fair value of the consideration given in exchange for goods and services. Expenses are recognised when incurred (on an accrual basis).

BASIS OF CONSOLIDATION

In preparing the special purpose consolidated financial statements, the results of the disciplines outlined in note 1 above have been added together and all interdiscipline transactions, balances, income and expenses are eliminated in full on consolidation.

ESNZ is also affiliated with regional clubs, branches, and area groups. The results of these entities have not been included in the consolidation.

ACCOUNTING POLICIES

The financial statements have been prepared in accordance with the accounting policies set out below. These accounting policies have been applied consistently to all periods presented in the financial statements. There were no changes in accounting policies during the year which have impacted the recognition and measurement of balances presented in the financial statements.

RECOGNITION OF REVENUE

Revenue is recognised to the extent that it is probable that the economic benefits or service potential will flow to ESNZ and the revenue can be reliably measured, regardless of when the payment is being made.

Revenue is measured at the fair value of the consideration received or receivable and represents amounts receivable for goods and services provided in the normal course of business, taking into account contractually defined terms of payment, net of discounts and GST.

The specific recognition criteria described below must also be met before revenue is recognised.

REVENUE FROM NON-EXCHANGE TRANSACTIONS: High Performance Sport New Zealand and Sport New Zealand Funding

Funding from High Performance Sport New Zealand and Sport New Zealand is recognised as revenue when the conditions associated with the funding have been met, any funding received but not recognised as revenue is recognised as a liability until such time as the conditions associated with the funding have been met.

Grants

Grants are recognised as revenue when the requirements under the grant agreement have been met. Any grants for which the requirements under the grant agreement have not been completed are carried as liabilities until all the conditions have been fulfilled. This includes the wage subsidy received during the year.

Sponsorships and Donations

Sponsorships and donations are recognised as revenue when cash is receipted by ESNZ.

REVENUE FROM EXCHANGE TRANSACTIONS:

Investment Income

Interest income is recognised consistently through the financial year based on the effective interest rate applicable to the investment.

Membership Income

Revenue received from membership subscriptions is recognised proportionately over the period to which they relate. Any unearned membership subscription funds are carried forward as deferred revenue on the statement of financial position.

Camping, Rent and Ground Fees

Camping, Rent and Ground Fees are recognised as revenue when cash is receipted by ESNZ.

Other Income

Other income includes provision of education, tours and events, sale of goods and services and sundry income. Other income is recognised as services are provided or the risks and rewards associated with goods sold are passed on to the customer.

Employee related costs

Provision is made for benefits accruing to employees in respect of wages and salaries, annual leave, long service leave, and sick leave when it is probable that settlement will be required and they are capable of being measured reliably. Provisions made in respect of employee benefits are measured at their nominal values using the remuneration rate expected to apply at the time of settlement.

Financial Assets

Financial assets are recognised when ESNZ becomes party to the contractual provisions of the financial instrument. Financial assets are classified as either financial assets at fair value through surplus or deficit or loans and receivables.

Financial Liabilities

Financial liabilities include payables and term liabilities. Financial liabilities are initially measured at fair value net of transaction costs and are subsequently measured at amortised cost using the effective interest method. Interest expenses are recognised in surplus or deficit on an effective yield basis.

Cash and Cash Equivalents

Cash and cash equivalents are short term, highly liquid investments that are readily convertible to known amounts of cash and which are subject to an insignificant risk of changes in value.

Accounts and Sundry Receivables

Accounts and sundry receivables from exchange transactions are measured at amortised cost using the effective interest rate method and are reported net of provisions for impairment to reflect estimated recoverable amounts.

Short Term Investments

Short term investments comprise term deposits which have a term of greater than three months and less than 12 months and therefore do not fall into the category of cash and cash equivalents. These are measured at amortised cost using the effective interest rate method less impairment. Interest revenue is recognised by applying the effective interest rate. Short term investments are entered into generally for periods of 12 months or less and are therefore classified as current assets in the statement of financial position.

Foreign Currencies

Transactions in foreign currencies are converted at the New Zealand rate of exchange ruling at the date of the transaction. At balance date foreign monetary assets and liabilities are translated at the closing rate and variations arising from these transactions are included in the statement of comprehensive revenue and expenses.

Property, Plant and Equipment

Property, plant and equipment is recorded at cost less accumulated depreciation and any accumulated impairment losses. Costs includes expenditure that is directly attributable to the acquisition of the assets. Where an asset is acquired for no cost, or for a nominal cost, it is recognised at fair value at the date of acquisition.

An item of property, plant and equipment or investment property is derecognised upon disposal or when no further future economic benefits are expected from its use or disposal. Impairment losses are reversed when there is a change in the estimates used to determine the recoverable amount.

Restricted Funds

Restricted funds represent funds received and set aside to be used for various and specific purposes. The funds are initially recognised as revenue from non-exchange transactions in the statement of comprehensive revenue and expenses in the period that the fund are received.

Operating Leases

Operating lease payments, where the lessors effectively retain substantially all the risk and benefits of ownership of the leased items, are recognised as an expense in profit or loss on a straight line basis over the lease term.

Goods and Services Tax

All amounts are stated exclusive of goods and services tax (GST) except for accounts payable and accounts receivable, which are stated inclusive of GST.

- 1. Taupō Hunt Incorporated advanced \$250,000 to assist with the construction of the indoor arena. The loan is repayable over 10 years by monthly payments of interest and capital until 31 May 2027 at an interest rate of 5.25%. The amount outstanding as of 31 May 2023 is \$106,700 (2022: \$136,609).
- Supporters of Fibre Fresh National Equestrian Centre (Taupō) extended two loans totalling \$300,000, for the
 completion of the indoor arena. These loans are interest free and are unsecured and are repayable on demand. The
 amount outstanding on 31 May 2023 is \$50,000 (2022: \$100,000).
- 3. During the year ESNZ made use of the Small Business Cashflow Loan made available because of the Covid-19 pandemic. The Norwood Trust was established in 1967. Interest income is intended to fund the prize for the Norwood Gold Cup competition at the Horse of the Year. Interest due on the term deposit of \$169 (2022: \$24) was recognised during the year.

The WR Duncan fund was established in 1989 with a bequest of \$15,000. Subsequently the balance in the European Tour and a bequest from the estate of JJ van Loghem have been added to the fund. Income is to be used for the training of technical officials across all disciplines on a rotational basis. The funds are invested in a term deposit on each year for a period of 12 months. The current investment matured on 8 June 2023 and was reinvested at an interest rate of 5.75% per annum (2022: 3.15%).

The JN Lowry Fund was established in 1962. The purpose of the fund was to provide the Lowry Medallion, that is awarded to the rider gaining the most points over the Horse of the Year Show. As the income earned on this fund no longer meets the annual cost of the medallion, income is not recorded separately and the cost of the medallion is met by ESNZ.

The Creswell Fund was established in 2014 pursuant to the terms of June Creswell's will. The fund was allocated to the Christchurch National Equestrian Centre for the construction of covered yards. The interest accumulated on the fund is to be used for prize money in the major Showjumping Nationals held at the Christchurch National Equestrian Centre.

The Secretary General of ESNZ, Vicki Glynn was appointed as a director in June 2015 and the former President of ESNZ, Richard Sunderland was appointed as a director in April 2018. Each of the three shareholders provided shareholder loans of \$30,000 to establish the company. The shareholder loan to Horse of the Year Ltd was impaired in ESNZ financial statements in the year ended 31 May 2014. The Horse of the Year Ltd shareholder loan remains impaired as at 31 May 2023.

As stated in Note 1 there are disciplines whose results are consolidated into these financial statements. In addition, there are other potential related parties in the form of organising committees and area groups throughout New Zealand who are connected through the various disciplines but whose financial activities are not reflected in these statements.
