Promotion Pathway for ESNZ Jumping Officials



ESNZ Jumping Judge

National Level 1 Judge

- Be a minimum of 18 years of age and current financial member of ESNZ
- Be familiar with ESNZ Jumping Rules and General Regs.
- Demonstrated knowledge and practical skills required to carry out Jumping Judges duties
- Complete the application form for ESNZ Jumping Judges
- Recommendation by Area Group or listed Jumping Official

National Level 2 Judge

- Demonstrate good knowledge of Jumping Rules, Gen Regs, and ESNZ policies
- Two years as Level 1 Judge
- Attended in person National L1 Jumping Judges maintenance course in the last 3 years
- Member of the Ground Jury at a minimum of 6 or more ESNZ sanctioned jumping events in the last 2 years
- Assisted National L3 Steward or higher on at least 2 occasions
- Assisted a National L2 or higher CD on at least 2 occasions
- Been assessed and have written recommendation by 2 minimum National L2 judges
- Recommended by Area Group
- Pass Open Book test at an official ESNZ Jumping Judges promotion course, including a one-on-one interview

National Level 3 Judge

- Have in-depth knowledge of ESNZ Jumping Rules and ESNZ General Regs
- Understand the FEI Jumping Rules and General Regs
- Attended an in-person National Jumping Judges maintenance course at least every 3 years
- Demonstrated required knowledge, practical skills and behaviour required to carry out Jumping Judges duties
- Be able to work under pressure and take responsibility
- Have good communication skills and professional at all times
- Act as Assistant Course Director at a National L1 Jumping judges maintenance course
- Have a practical assessment by a FEI L1 judge or higher
- Have a one-on-one interview with a FEI L1 judge or higher
- Pass Open Book test

National Level 3E Judge

- National Level 3 Judge for a minimum 3 years
- Ground Jury member at at least 6 ESNZ Premier or GP sanctioned Jumping events in the last 2 years incl President of the Ground Jury at 3 events in the last 3 years
- In depth understanding of ESNZ Jumping Rules and ESNZ General Regs
- Good understanding of the FEI Jumping Rules and FEI General and Vet Regs
- Have read and accept the ESNZ General Code of Conduct.

ESNZ Jumping Course Designer

National Level 1 Course Designer

- Be minimum of 18 yrs and a current financial member of ESNZ
- Attended at least one yearly seminar for National Level Course Designers
- Competitor or regular assistant to min National Level 2 CD
- Send CV to apply
- Recommendation by Area or a minimum Nat L2 CD. If rider has ridden HGP level, they may be nominated with Area support.

National Level 2 Course Designer

- Has acted regularly as National Level 1 CD for at least 2 years within and outside your area
- Attended at least one seminar for National level CDs in the last 2 years
- Recommended by Area Group
- Kept a signed logbook
- Recommended by 2 x National CDs higher than your level
- Pass Open Book test for CDs

National Level 3 Course Designer

- Promotion based on demonstrated proficiency as a CD at high level competitions sanctioned by ESNZ Jumping
- Regular CD at ESNZ Events (high level competitions)
- Attended one seminar for National level CDs in past 2 years
- Assisting FEI L3 CD x 2 with sign off
- Kept a signed logbook
- Completed online FEI L1 CD course
- Recommended by 2 x National L3 CDs or higher, that you have worked with
- Recommended by Area Group

- Have attended maintenance courses for National L3 Jumping Judge's, Stewards, and CDs, in the last 3 years
- Have an up to date ESNZ Jumping Judge's logbook and or CV
- Have been assessed and recommended by two FEI Level 1 Judge's or higher
- Have assisted both an FEI Level 2 Jumping Course Designer and FEI Level 2 Jumping Steward or higher, each on at least two occasions
- Pass an open book test for ESNZ National Level 3E Jumping Judge's including a one-on-one interview



ESNZ Jumping Steward

National Level 1 Steward

- Be minimum of 18 years and current financial member of ESNZ
- Basic understanding of ESNZ Jumping Rules and ESNZ General Regs
- Desire to further knowledge and progress within Steward Pathway. L1 is a chance to understand the role of a Steward at ESNZ sanctioned events
- Send CV outlining equestrian background and experience

National Level 2 Steward

- Understanding of ESNZ Jumping Rules and General Regs
- Knowledge of other Jumping roles
- Attended at least one ESNZ Seminar for Stewards in last 3 years
- Shadowing at 3 ESNZ Jumping Events with a minimum National L3 Steward
- Recommended by a minimum of Jumping National L3 Steward
- Signed off logbook
- Recommended by Area Group

National Level 3 Steward

- Good understanding of ESNZ Gen Regs, Jumping Rules and FEI Stewards Manual
- Nat L2 steward at minimum 6 x ESNZ Jumping Events, two being Premier
- Signed off logbook
- Pass open book test
- Recommended by Area Group
- Positive performance-based assessment from ESNZ Jumping Steward higher than your level

ESNZ Jumping Technical Delegate

National Level 1 Technical Delegate

- Be minimum of 18 years and current financial member of ESNZ
- Good knowledge of ESNZ Jumping Rules and Gen Regs, knowledge of Stewards' duties and when to assist them
- Send CV outlining equestrian background and experience
- Recommendation by Area Group, and a National L2 (min) Technical Delegate
- Attended seminar for Judges, CDs, Stewards in last 2 years.
- Be minimum National L2 CD
- Be approachable by riders and officials, be able to deal with conflict in a quiet manner, and have good people skills

National Level 2 Technical Delegate

- Have been active National L1 TD for at least 3 years, including 3 TD roles outside of your area.
- Recommendation from 2 National L2 TDs, an FEI L3 Judge, an FEI L3 CD and your Area Group.
- CV completed, detailing L1 TD experience
- Thorough knowledge of ESNZ General & Vet Regs and Jumping Rules, knowledge of Stewards' duties and be able to assist them when required.

National Level 3 Technical Delegate

- Active National L2 TD for at least 3 years, including 3 TD roles outside of your area.
- Recommendation from local Area Group
- Have officiated as National L2 TD at least 6 events within three years.
