FEI Forum:

- Felt that FEI was out of sync with NZ and what relevant issues were here as opposed to Europe and the opportunity to do this in person was very important.
- Noting, Endurance may also be sending a representative.

HOY Jumping and SH Show:

- Interest had been expressed from several OCs to run a Pop Up HOY Jumping Show.
- Sophie from HOY joined the meeting at 11:30am. Shared her visions for the LRHOY.
- The Board was keen to support, but concern about who was underwriting.

- There is a HOY Board meeting Tuesday night, which after Sophie would be able to provide more information.
- Sophie wanted to do a survey amongst members to see if there was an appetite for a pop up HOY.
- Was moved that the Jumping Board support LRHOY and partner in underwriting subject to approving a budget and survey on desire from riders.

Age Group Classes:

- Very low entries in age group series classes in lower North Island and South Island.
- Noted that ideas from membership need to go to the Technical Committee first.
- PX said that the SI riders meeting had a lot of concerns re age group series and the general feeling was they need to be at a lower height.
- More discussion needed at a rider level, PX to organise a specific rider meeting to discuss this.

Crowded Dates Card:

- South Island has limited time frame due to weather restrictions.
- Would like to organise dates card better so there was more flow between North and South islands.
- Concerns around some big clashes on dates card, ie Taranaki and Gisborne.
- Discussed having a Dates Card Committee, but noted this would be difficult as had to work with OCs and their restrictions including access to grounds.
- Discussed the quality of premier shows and their ability to provide live streaming, gear etc., Put aside for more discussion around this at a future meeting.
- There was discussion on the future venues of specialty shows. Series Finals/Young Horse show and Nationals up for contract renewal at end of 2023 season.

Show Hunter:

- Waitemata had asked to have HOY qualifying points at their show on the 4-5 March. Board approved. Waitemata has been advised.
- 3Taupo NEC booked for 5-6 August 2023
- Need to have a NI committee to run the camp

Series Finals Presentations:
