- a) NO DOGS ALLOWED (automatic rider disqualification if not complied with)
- b) Payments not received by 21 April 2020 will incur a late fee of \$20 per horse – can be paid when picking up back number**
- c) All scratchings must be made through [www.equestrianentries.co.nz](http://www.equestrianentries.co.nz)
- d) By making an entry, riders are liable for all fees, even if they do not attend the event. If you subsequently scratch, the refund policy will apply. Please note: Administration and Late fees are non-refundable.
- e) Competitors must comply with the requirements of Article 634 Medical Information and provide telephone number of accompanying person/next of kin for event Secretary, either by having entered it on your Equestrian Entries Profile or notifying the office when picking up Back Number.
- f) Back number holders are required.
- g) Entries from Hawke's Bay Riders are required to supply name of one volunteer, in the special requests area of the online entry, however the Committee welcomes any offers of help on the day
