

**Record of ALL Wins of a Novice Horse/Pony**  
**CDE6: Novice Classifications**

- A Novice exhibit or rider is one that has **yet** to win six (6) classes in any division within the competitions provided at any A&P Show/Event.
- Wins at all affiliated RAS Shows including the NZ Horse of the Year (HOY) Show must be recorded on the RAS Certificate and/or Performance Card.
- All wins in Novice classes within each section (**not breed sections**) count and must be recorded on the RAS Certificate. Should a Novice exhibit win an Open conformation class including Ladies and Gents classes, these wins must also be recorded.
- Winners failing to produce their card when requested by the Steward forfeit their awards on the day.
- The number of wins is to be counted, at time of first day of the Show/Event competition.
- Any wins gained overseas by a horse/pony that is imported into New Zealand, count towards their classification when showing in NZ.

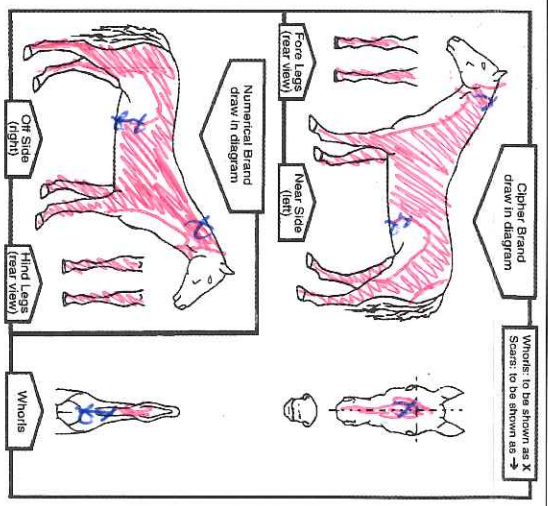
**PLEASE NOTE:**

CDE 1a) Where classes are defined by height, competitors/exhibitors must carry a current RAS Certificate for their horse/pony at all RAS affiliated Shows/Events, and must produce it upon request to any authorised Show/Event personnel. Any competitor unable to produce such a certificate means that the exhibit is ineligible to compete, and will forfeit any awards.

**You, as the Owner or Person Responsible are to notify the RAS** if the Horse/Pony - has a change of ownership/lessee, and/or contact details, or has been leased - See Rule ER8.z) - change of ownership form can be downloaded from the RAS website.

**Measuring:**

All RAS approved Measuring Stands and their contact details are listed on the RAS website. As they become available, measuring dates and times are also stated. When you require a Life Certificate for your horse/pony, the owner must contact the Stand prior to measuring day to advise them of this. Owners must also obtain the appropriate Vet Identification form from the Stand, which must be completed prior to, or on measuring day by a registered Veterinarian.
