- **TIMETABLE**: Dressage and Showjumping Saturday; Cross-Country Sunday.
- Back number holders are required for all classes.
- All classes run under all applicable FEI rules and regulations or ESNZ Eventing rules effective 1 August 2023. version 8.0
- **XC Open for Walking** 3pm Friday.
- FEI classes Must check in at one of the two times provided in the rider notes. Temperatures will need to be taken 3 days prior.
- Riders must use their XC back number when schooling. Armband or bridle number in dressage and show jumping (or XC back number). All horses must always have an ID (either a personal ID or their competition number) on them whether being ridden or in the yards as per Article 651. It is preferable that those competing in National Classes (CCN and NZPCA) wear their XC #'s in all phases.
- **Back protectors** are compulsory for cross country (including in the warm up) and MUST meet the new standard BETA EN13158 2009/2018 Level 3 or ASTM 1937.
- **Helmets** must be yellow tagged for all phases. If required please bring helmet to the office for inspection before start of competition or risk elimination.
- **Dogs** MUST be on a leash at all times and under control or you could be Eliminated.
- **NO** unofficial vehicles outside the parking areas.
- We are a smoke free venue.
- All Bikes you must wear a helmet or could be eliminated.
- XC Day there is to be no bikes on the course.
