Christine presented a comprehensive .ppt about the squads structure which is team based around riders and support crew. A copy of this to be distributed with the minutes. While the Performance and Development committee has a significant scope looking after many parts of dressage development from grass roots riders through young riders and developing performance riders to established senior and professional riders targeting Olympic and WEG events. most of the work is seen as being the 'squads' and this year has seen a committed group of squad riders connecting in various forums to grow their skills and knowledge. One of the challenges the Performance and Development committee is grappling with is how to support our High Performance Riders alongside our National Squads and how to make sure the connection of these two joined up but separate programmes can be achieved to really leverage the value and the opportunities for both groups in the best interests of our sports future.

This year saw the introduction of a Sports Administrator for the Performance Committee to help with administration, logistics and communication. Christine thanked Sarita Kennedy who was appointed to this role and co-opted member Justine riders within their circle. Our squad programme is trying to develop in a way that recognises and supports the team effort required to produce winning performances.

6.6.1 ESNZ HIGH PERFORMANCE

Warrick Allan (ESNZ HP Operations Manager) submitted an apology for Jock Paget (ESNZ HP Manager) as he is currently with the team at the Tokyo Olympics.

Warrick noted the difficulty for NZL dressage combinations to qualify and meet the performance requirement set by the NZOC for Tokyo OG. That the focus is now on getting a team together for the World Equestrian Games in Denmark 2022. The goal is set high with a top eight team finish and hopefully a team qualifier for Paris Olympics in 2024.

A review of the selection criteria for the High Performance (HP) and High-Performance Futures (HPF) squads has seen an adjustment. The scores for HP squad selection have been lifted. The rationale for these changes to HP is to align with the performance requirement to be nominated for Olympic selection to the New Zealand Olympic Committee.

ESNZ HP acknowledged and thanked the Dressage community, being impressed with the passion and commitment shown and how pro-active everybody is in trying to improve this sport.

During report discussions re World Equestrian Games in Denmark 2022 it was noted riders may need to consider competing offshore to qualify as the options to run CDI competitions in New Zealand due to the restrictions of COVID.

John Lawson (Evo Events) asked if ESNZ HP were in discussions with Australia to create a trans-Tasman competition. The Sport manager noted current Trans-Tasman agreement needs to be reviewed, especially around financial liability of the host country.

6:7 MARKETING

Alicia Cameron

The Sport Manager presented the Marketing report on behalf of Alicia who was unable to attend.

A new promotional video was shown to the room. Video link here Using the beautiful Takapoto Estate as the backdrop, various riders and officials shared with us just what makes Dressage so special, and what they love about the sport. This video will be used to promote our sport to attract new riders, supporters, volunteers, and sponsors while highlighting the amazing people we already have involved in the sport.

There are potentially a couple of promotional opportunities coming up including the possibly of a WEG fundraiser in collaboration with FV Jewellery. The first Dressage by the Lake at Takapoto was a fantastic marketing tool for the sport, this also highlights that we have to keep looking at ways to keep attracting new people to the sport.

Alicia noted a highlight for her first year was the Dressage Change the Rein Facebook campaign. Our series of five posts over five days had a reach of 10,449 and received close to 2,500 engagements, which demonstrated how engaged our members were.

- Generate an email to the place getters of the sponsors class – with the sponsors contact details
- Can put sponsors logo on the class, with a hyperlink to their website – with page view stats post event
- Can put dressage writers into the system and they print out onto the judges sheets
- Sub-committees – have data drilled down to every judge, test, movement – allows to give huge data analysis
- Clinic software – allows timetable groups, assign people to groups, assign coaches.

CURRENT RULE /ARTICLE NUMBER : 479.2

Amendment

White or light-coloured breeches/jodhpurs. The seat may be dark colour.

RATIONALE: To make the colours of jodhpurs/breeches the same for all levels so riders to not have to change from one level horse to another.

Proposed

Jodhpurs | Breeches

All Levels:

White, off-white, light canary, banana, light grey or beige jodhpurs or breeches

If “full seat” style breeches or jodhpurs are worn, dark colours black, brown or grey are allowed in the “full seat”

Note: Planning Forum delegates agreed in principle that the intention of the remit is that jackets are compulsory at RE & NCH but that riders should be able to exercise their own discretion to wear a jacket or not in high temperatures

Art 479: Dress

No change to jacket rule for TE & LE (All levels – graded and non-graded)

Current rule: Riding Jackets are optional at Training & Local Events at all levels

Regional & National Events

Current rule: In the interest of health and safety during weather extremes at RE & NCH, the OC may give permission at their discretion, for athletes to compete without a jacket.

Remit:

Delete the above sentence and replace with the Dressage Australia rule

Wearing a jacket is optional if the rider feels overheated

a) ***North and South Island Rider Representatives will be elected annually via an online system prior to the Dressage NZ AGM.***

b) The two Rider Representatives will hold positions on the DNZ Committee **(No change)**

c) The Rider's Representative will organise and Chair the riders meeting at their respective Island Championships ***(or other PL league show if there is no Island Championships)***

d) Any rider who is a current full or Junior member of the ESNZ may speak and vote at the Rider's meeting

~~e) A parent / guardian may speak and vote on behalf of a rider under 18 years of age — they themselves do not need to be a financial member of the ESNZ~~

Remit 4: Unauthorised / Outside Assistance

CURRENT RULE/ARTICLE NUMBER : Article 451.2.5

Current rule:

Any assistance to get a horse into the dressage arena or the area directly around the arena, including being led by another horse around the arena is considered outside assistance.

REMIT:

If necessary, a horse may be assisted in the area directly around the arena, but once the Judge's bell has been sounded any further assistance will be considered unauthorised / outside assistance.

Note:

The meeting to consider if this assistance may only be by handler on foot, if a lead rope is permitted, if another horse may lead the horse having the problem ... etc

Organising committees have the discretion to disallow assistance around the arena before the bell has rung exempt for specific competitions/arenas but this must be stated [where? In the schedule? (eg the main oval at HOY)]

Note: *Where must this discretion/ exemption be stated?*

This amendment was passed in principle at conference but implementation subject to advice/consultation re any H & S implications and risk analysis

Following further discussion and consultation, the Dressage NZ Board meeting of 11th August 2021 resolved unanimously to refer this rule provisional change back for further review in the 2022 revisions to enable all other rules connected to this rule to be reviewed and aligned.

Remit 5: Unauthorised / Outside Assistance

Art 451.1

Reference to examples of Outside Assistance

Need to align Table of Penalties with Art 481

- Penalty for Riding with Earphones
ADD and other communication devices
- A Smart Watch may be worn but must not be used as a communication device

Item 11. 2021 Young Dressage Horse Competitions Review

Linda Warren-Davey for Sub-Committee:

Presenters: Linda Warren-Davey and Jody Hartstone, with a PowerPoint presentation

The concept of the proposal was outlined with the basic principles of YDH competitions being to **Nurture, Develop, Encourage, Educate and Promote**
Summary

- to encourage as many riders as possible to enter young horse classes at Premier League Shows which will be run in a non- competitive format but will also serve as a qualifier for the Young Horse Finals.
- This will allow riders to ride their young horses at a level that suits their stage of training and maturity, and still be able to benefit from the feedback given by qualified YDH judges.
- There are two New DNZ tests for each of the 4-6yo age groups. The Round 1 tests will be the tests used for qualifying at PL shows. The Round 2 tests will be used only at the finals.
- **Qualifying Shows:**
PL League Shows are encouraged to run YDH Classes for 4, 5 and 6yo horses. These are to be judged by YDH qualified Judges. Other shows that are wanting to offer these classes to provide training opportunities are also encouraged to do so.
- These classes will be scored in the usual way however marks will not be made public, and placings will not be announced. There will be no prizemoney for these classes but all horses receiving a qualifying score will receive a special qualifying rosette. A lower entry fee is encouraged for these classes as there is no prizemoney. Riders will receive their test sheets and feedback as per normal, but the emphasis is on the classes being educational, encouraging, and developmental. A qualifying score of 65% will be needed to enter the finals.
- Any horse aged 4-6 may enter the YDH classes on offer. They may enter a test lower than their age but will be noted as H/C and the score will NOT be counted as a qualifying score for the finals.

NZ Finals and South Island Finals:

A final held in each island will be a celebration of NZ's best young horses and their breeders.

The South Island Finals will be held at the Festival of Future Stars and the NZ Finals will either be held at the NZ Nationals or at Takapoto or similar. Both finals are to be held as late in the season as possible.

Proof of age and breeding for horses entering the finals will be required by way of breed papers / passports. Riders are encouraged to lodge their horse's breed society papers with the ESNZ and ensure the "Validation tick" is shown on their horse's information on the ESNZ database. Riders are also encouraged to make sure the correct breed, sire and dam as well as the breeder is included in the ESNZ database for the horse

Item 12: Amateur and Rider Classification Review

Verbal Presentation by Jody Hartstone and Debra Cowen on behalf of the subcommittee

Summary

For the last 2 years (2020 & 2021) it has been raised at the North Island Riders meeting that the Amateur classification system has not been working as intended. This was raised again at the 2021 Planning meeting and agreed that a subcommittee be established to review the current system and explore the possibility of a new system that will better meet the needs of our riders especially those new to our sport and those moving up a level for the first time.

Aim: To provide a classification system that encourages new riders to participate in the sport of dressage as well as providing a pathway encouraging existing riders to try a new level.

As a result, we agreed that a rider who is regularly achieving over 70% and a new rider achieving 60% at that level and are both currently considered Amateur due to their current DNZ rider classification, should not be in the same peer group. We consider this situation is not achieving the agreed Aim or Outcome 1 above.

Gold Silver Bronze

The subcommittee felt that the British system needed amendment and simplification to better align with dressage competition in New Zealand.. They are;

- The level that the rider has competed on any horse within a time period; and
- The number of performances that as a combination (horse and rider) have achieved above a determined percentage at the level they wish to compete.
- From this we developed the Section Classification Tables and Notes – these are attached.

To determine the rider level and the percentage/number for the combination the subcommittee carefully reviewed several PL show results and determined the criteria of the Section Classification provide a reasonably equitable split across sections for the shows reviewed.

The meeting was supportive of the proposal outlined with further discussion to be held at the committee meeting

Item 13: Youth Representation Proposal

The Planning Forum 2021 approved in principle that the Dressage NZ support the introduction of Youth Representation at Dressage national level.

The Young Rider Panel presented a .ppt which was well received by the meeting and the principles of youth advocacy agreed
