Conditions

- a) To start all riders must have current ESNZ membership except class 7&8, for which riders may start on a casual membership
- b) Unregistered horses in classes 3 to 8 may start on a casual ESNZ Equine Registration of \$5 per horse.
- c) Unregistered horses, or horses with no eventing discipline start, may start in classes 3 or 4 with an Eventing Flexi Start of \$15 per horse.
- d) Food and farrier available on grounds.
- e) Committee reserves the right to alter the programme and prize money, and to substitute prize money with goods to the value of, at their discretion – Article 611.
- f) No non competition horses on the grounds.
- g) As a condition of entry all local BOP riders must supply a helper prior to or during the event.
- h) All classes part of NRM ESNZ Eventing National Series Competitions.
- i) All classes run under ESNZ Eventing Rules.
- j) **Article 610 – DISCLAIMER OF LIABILITY**
Neither the Organiser of any event to which these rules apply, nor the National Federation, nor any agent, employee or representative of these bodies accepts any liability for any accident, loss, damage, injury or illness to horses, owners, athletes, spectators, land, vehicles, their contents and accessories or any other personal property whatsoever whether caused by their negligence, breach of contract, or in any other way whatsoever.

Ground

- 1) All horses to have a yard. No horses tied to trucks or floats unless saddling up.
- 2) Dogs to be on a lead at all times.
- 3) No unauthorised motorbikes on the grounds.
- 4) **All Yards are to be left in a clean tidy condition. If your yard is left dirty you will be fined \$50**

Timetable In order to accommodate everyone we reserve the right to run all phases of some classes on one day. Timetable to be advised after close of entries.

Prizes can be collected from the secretary's office 30 minutes after results are signed off by TD. Class winners may be required for prizegiving in correct dress with their horses.
