ESNZ BOARD SUMMARY

15TH FEBRUARY 2017

The ESNZ Board met on the 15th February 2017 in Wellington, the following is a summary of key outcomes from the meeting.

HEALTH & SAFETY

The Board was made aware of two incidents that had recently occurred at Taupo NEC.

- A grass fire on 10 January which was ignited by a spark from the mover while mowing the cross country course.
- Gas explosion on 10 February motorhome staying onsite exploded as a result of gas works carried out by owner of the motorhome. Owner suffered serious burns to his arms and legs and was taken to hospital.

As a result of the above incidents the following actions have/will be been taken:

- Christchurch NEC notified to avoid doing the same. Plan to cut Cross-Country track pre Xmas in future to avoid dry conditions.
- Fire extinguishers have been fitted to tractors
- Claim underway through ESNZ insurers to cover cost of firefighting services.
- Notice to be placed on the website reminding members to have their gas cylinders tested regularly and make sure they are approved.

DISCIPLINE & NEC SERVICE FEE REVIEW

Proposals had been provided to Disciplines, NECs and High Performance in early January for discussion and to provide feedback. Nearly all entities had approved their service fees for 2017-2018. This review is tracking to schedule.

HORSE OF THE YEAR SHOW

ESNZ had consulted all disciplines and received feedback on the future dates of the Horse of the Year Show. It was agreed that the best date for the ESNZ calendar was mid-march.

To give stability to the disciplines, dates were set for the next three years as follows:

- 13-18 March 2018
- 12-17 March 2019
- 10-15 March 2020

PRESENTATIONS

The Board received a presentation from High Performance Director, Sarah Dalziell-Clout, who took the Board through the High Performance strategy for the next two years through to the 2018 World Equestrian Games in Tryon.

The Board also received a presentation from National Sport Administrator, Heidi Bulfin who provided the Board with an overview of the ESNZ Coaching Programme and how ESNZ could collaborate with NZPCA. To this end, disciplines are reminded to appoint a representative to be part of a Pony Club/ESNZ relationship working party.

FINANCE

After much discussion the Board agreed to cash up the Life Membership Fund Term Deposit to repay the ANZ overdraft facility and seek funding from the disciplines. The Life Membership Fund would be rebuilt once the organisation was back on track.

The Board then had a discussion around borrowing funds from the disciplines. The Board requested that a pro-rata system be used to determine how much money would be borrowed from disciplines and provide a report to the next meeting.
