



# JUMPING – SENIOR RIDER TRANS TASMAN SELECTION & PERFORMANCE CRITERIA

**Event:** Senior Jumping Trans Tasman Test

Location: Willinga Park, Bawley Point, NSW, Australia

Dates: 12<sup>th</sup> – 15<sup>th</sup> September 2024

Competition Details: Event held over two rounds at 1.40m under article 264.1

#### 1. Objective

The primary objective of this selection criteria is to identify and select the best-suited horse-rider combinations to represent New Zealand in the Trans Tasman Test, ensuring a competitive and successful team performance while providing development opportunities to combinations targeting the 2026 FEI World Championships.

# 2. Eligibility Criteria

To be eligible for selection, riders and horses must meet the following basic requirements.

#### Rider Requirements:

- Must be a New Zealand citizen or permanent resident.
- Must hold a current ESNZ membership.
- Adhere to the requirements as listed in Chapter Three of the ESNZ Special Regulations for National Selection – click here to view

# Horse Requirements:

- Must be registered with ESNZ.
- Must have a valid FEI passport.
- Must meet health and fitness standards as verified by an ESNZ.

#### 3. Selection Process

The selection process is divided into two stages:

# Stage 1: Expression of Interest (EOI) Submission

Riders must submit an Expression of Interest (EOI), including details about themselves, their horse(s), pertaining to 4.1-4.5 and past performances from 1<sup>st</sup> January 2023.

# **Stage 2: Performance Assessment**

Evaluation of the combinations results and performances being considered from 1<sup>st</sup> January 2023 to present at a height of 1.40m and above.

- Recent Competition Results: Riders must submit their performance results from key competitions since 1<sup>st</sup> January 2023, with an emphasis on international competitions and top-tier national events.
- Grand Prix and World Cup Events: Results from Grand Prix and World Cup events will have greater significance

### 4. Selection Criteria

The final selection will consider the following criteria:

#### 4.1. Competition Performance

- Clear Round Consistency: The frequency of clear rounds
- Notable Wins: Significant wins or achievements in major competitions that demonstrate the rider's ability to perform at the top level.

 Technical Execution: Ability to execute technically challenging courses with precision and efficiency.

# 4.3. Team Dynamics

- Teamwork: Ability to work collaboratively within a team structure, supporting team goals over individual achievements.
- Communication Skills: Effective communication with team members, coaches, and support staff.

# 4.4. Physical and Mental Fitness

- Rider Fitness: Rider's physical fitness level to handle demanding competition environments.
- Mental Resilience: Ability to stay focused, calm, and adaptable under pressure.

# 4.5. Veterinary and Health Assessment

- Horse Health: Current health status, recovery ability, and risk of injury.
- Fitness Levels: Horse's fitness and stamina to withstand the rigors of international competition.

#### 5. Other Factors

The selectors may also take into account the following factors:

- 1. any other factors which they consider applicable to their decision, such as those set out in Article 14 of the ESNZ Special Regulation (National Selection); and
- 2. the willingness of the rider, the horses' owner(s) and support team) to contribute positively to the Objective of this Selection Criteria.
- Greater selection consideration will be given to combinations aiming for 2026 FEI World Championships
