11. South Island Champs

- Friday works OK if it is a public holiday as it was in 2015 when the South Island Champs were held in Marlborough.
- If CTR held on Friday then riders may need to take an additional day off work to be able to compete.
- The budget and ride programme were approved subject to the CTR classes being moved to Saturday.
- Shifting to the Saturday should also make better use of vets and officials and help to keep costs down. Vets, officials and crew won't need to stay around until late Friday waiting for the CTR Open riders to finish.

 - Should the club go into recession; the club's assets will be frozen for a period of 3 years. A quorum of members (when the club went into recession) can agree to bring the club out of recession at any time during the 3 years. After 3 years, all assets will revert to ESNZ Endurance.
