### Financial Position YTD 28/2/18

Finance Officer Sara Bright noted the change in the ESNZ has impacted Dressage NZ income

There has been little impact in annual start income but non –graded participation and income has reduced significantly owing to the requirement to pay a membership fee.

There has been no income from annual starts for three months Dec – Feb owing to the new ESNZ finance system connected to the database being unable to report the figures. It is expected this will be resolved in the near future

#### Guest Speaker: Ken Allen Sport Wellington. Volunteer Succession Planning

"If we give better recognition to our volunteers maybe it will be easier to recruit and retain volunteer for our group. It is important to understand what motivates volunteers".

#### **Motivations - GIVERS**

**Growth**. How the individual will grow themselves from volunteering. Maybe it will look good on their CV. **Impact**. The impact the volunteer has on the organisation

Voice. Volunteering enables the person to be involved and have their say

Experience. They gain experience in the sport from an inside perspective

Recognition. It feels good to be wanted and publically acknowledged for volunteering

**Social.** It provides social interaction or a social outing for the volunteer, where they can work alongside other like-minded people.

Some ideas included building a database of volunteers so that you can email them regularly and include them in the group.

Vital to give recognition to volunteers. Publically state what these people have done and what impact it had for the group. Show how the volunteer has grown as a result of volunteering.

# AGENDA ITEM 3 WEG Update Strategic Plan Priority – A Team to WEG 2018

The Sport Manager advised the meeting that she felt honoured, excited and humbled to be appointed as Chef d'Equipe for the NZL riders for WEG 2018

### **Summary of SM Presentation**

Wendi Williamson sadly lost her potential team horse Déjà vu MH to colic after HOY and currently NZL does not have sufficient qualified riders to field a team at WEG.

Without a team at WEG, NZL does not have the opportunity to qualify a team for Tokyo OG 2020. There is still time for other combinations to qualify. NZL is permitted to send one or two individuals. A CDI has been introduced to the show programme at Taupo later in April plus there is a CDI in Australia in June which would be another qualifying opportunity for NZL horses.

NZL riders were initially planning to campaign in Europe prior to WEG but now are looking at going straight to the USA via Sydney, Singapore and Anchorage. An advantage of this route is that the horses can go into quarantine in Kentucky soon after the games and be back to NZ 6-8 weeks earlier than if going back to Europe. There is a CDI 3\*competition the horses can compete at near New York a month prior to Tryon.

The Tryon athlete and officials accommodation is not going to be completed finished by September so will stay in hotels. The grooms will be able to stay on site.

Return flights to the USA are approx \$70,000NZ including home bound quarantine. The horses will possibly fly mid July. There will be many other costs riders will have including accommodation and agistment. Sharn Wordley has offered help with accommodation and contacts in the USA.

Dressage NZ has committed \$20,000 per rider with other fundraising to date at approximately net 10K. Contributors to date include the Walking for WEG by a group of officials, Waikato Dressage Group auction, Hobby Horse auction at nationals, Takapoto Estate auction and a donation from Dressage Central Districts. Riders entering nationals were invited to contribute with entries.

A short ppt presentation was shown of the Tryon venue

#### Fundraising: Michelle Zielazo (Marketing Manager)

Michelle noted that this project is about putting Dressage NZ on the map.

A monster raffle is planned hoping to raise at least \$30,000 from 300 tickets @\$100 each. Other items could be more appropriately auctioned.

EOI were sought from anyone interested in co-ordinating the raffle. Karen Shields suggested a silent auction could also raise funds

Michelle is also working on a retail offer to equestrian buyers, plus areas are invited to use local initiatives eg – WEG morning teas, make donations with show entries by adding a line on Equestrian Entries

# Officials Pathway Updates / Reviews

# 1) Judges - Sue Hobson (NJO)

The JSC have recommended that NZL adopt the 2019 version of the USDF tests and collaborate with AUS to make any adjustments to the "language" to make them consistent for AUS & NZ. One of the benefits of this proposal would be to allow easier Transtasman exchange of judges Dressage Australia currently uses the previous version of USDF tests with some small modifications and pay 10k over 4years. NZL Currently liaising with AUS to determine if we can submit an application to the USDF to secure a joint license under the Oceania Federation

The USDF tests are reviewed every four year and are currently being reviewed but are not quite ready for publication.

They have three tests plus a freestyle at each level for levels 1-5. There are still 0 level or introductory tests available.

The main differences in the tests are:

Level 2: Sitting trot is mandatory for the leg yielding. Elsewhere you can do either sitting or rising.

Level 3: Might have half passes in the trot

Level 4: has a single flying change each way

Level 5: is like our 5D test in that it has working pirouettes and a simple sequence change.

Level 6-9: remain the same

It is anticipated these tests would come into effect 1 August 2019

#### Questions asked

- Will downgrading be an option for current Level 4 horses unable to execute changes at time of implementation of the tests
- Will a double bridle be permitted at level 4 if changes are introduced
- Will there be an ongoing cost every four years
- Will the increased difficulty of the introduction changes at L4 be a road block for Amateur riders

It was agreed in principle that delegates take this proposal back to areas for further consideration with further discussion to be held at conference.

The JSC also recommended that NZL should also adopt the DA judge's classification and training programme. .

NZL List 1 judges would become A Level judges.

NZL List 2 and 2A would be given the chance to sit an exam. Providing they have an 80% + pass rate and shadow judge with a judge educator, they would be promoted to A Level. The exam would be held in Auckland, Wellington and Christchurch.

If List 2 or 2A decline this opportunity they would have B level status and be able to judge up to Int 1.

No area would be disadvantaged by this system and the sport would have more A level judges than we currently have List 1 judges.

This will be implemented only if we adopt the USDF tests alongside DA. If implemented, the JSC will conduct road shows explaining the new system and test requirements.

It was agreed in principle that delegates take this proposal back to areas for further consideration with further discussion to be held at conference.

# 2) Stewards - Jane Robertson (Steward General)

Jane Robertson noted with the meeting that it may be necessary to make changes to the rule to ensure all areas use stewards at events

The Sport Manager proposed a vote of thanks to Jane and her stewarding team who work such long hours, particularly at the national events

# **AGENDA ITEM 5: REMITS**

## **REMIT 1:**

#### **Re Abuse of Horses**

Submitted By: Alicia Zeludko (NI Riders Rep)

#### **NEW RULE**

That a rule be initiated that protects equine participants in dressage from abuse occurring through being ridden at a level higher than their capabilities.

#### **OPTIONS**

"That a certain number of scores at X level be obtained before being able to ride at that level in RE or above rated competitions"

AND/OR

"That if during a performance a horse scores a 4 or less on more than X amount of movements, and the final score is less than 50%, that the combination will be withdrawn by officials from that level for the remainder of the competition".

#### **Both options FAILED**

It was agreed that there are currently sufficient rules available to protect equine participants from abuse but officials must be clear about their application

#### **REMIT 2:**

#### **Re Prize Givings**

#### **NEW RULE**

That prize givings are only held no earlier than 30 minutes after the official results of a class are posted.

## **REMIT 3:**

Re: Arena Familiarisation

#### Article 473(4)(4.1) Arena Familiarisation

All arena familiarisation is under the jurisdiction and control of the OC and should be advertised in the schedule prior to the event. Arena familiarisation is defined as permission to work around the outside of the competition arena, unless the OC has stated this is allowed under Article 473.1.

- It was agreed
  - In principle arena familiarisation should allow walk, trot and canter around the outside or inside of the arena. Conditions of familiarisation will be left up to each area as event/ground conditions are different and may require amending for any reason at the event.
- The Rules Officer to amend the rules and present new wording at conference to reflect the above

# **REMIT 4:**

Re: Identifying young/green/problem horses with tail ribbon

#### **NEW RULE**

To be under Article 477 – Saddlery

For the purposes of safety, horses known to kick are permitted and encouraged to wear a red ribbon in their tail at all times whilst being ridden and/or handled except in actual competition. Young or green horses are permitted to wear a green ribbon whilst being ridden and/or handled except in actual competition.

Agreed in principle: The Rules Officer to amend the rules and present new wording at conference to reflect the above

5. AMEND CURRENT RULE/ARTICLE NUMBER: Article 477 (Saddlery) 4.10

That Article 477 (Saddlery) 4.10 be deleted and replaced with:

**REMIT:** That all Dressage New Zealand stewards are provided with an approved Noseband Taper Gauge in order to test the tightness of nosebands in an equitable way. This Noseband Taper Gauge needs to be used on the Nasal Planum (front of nose) to ensure that there is room for two fingers placed beside each other horizontally underneath the noseband.

Stewards MAY check noseband tightness at any time during an event. Any official / judge can ask a steward to check the tightness of a horse's noseband at any time during an event. If the noseband is found to be too tight before a dressage test has been ridden, the rider will be given the opportunity to loosen the noseband until it is of the correct tightness.

If the rider is found to have ridden a horse/pony in a test with a noseband tighter than set out in the guidelines for the Noseband Taper Gauge, they will be eliminated from that test.

Stewards MUST check noseband tightness using the taper gauge at all mandatory inspections.

6. re: Noseband Taper Gauge

**NEW RULE** 

That New Zealand Dressage Stewards be provided with an approved Noseband Taper Gauge so that noseband tightness can be checked in a systematic way without any room for subjectivity.

Although there was no support for the current rule, after lengthy discussion remits 5 & 6 both FAILED

It was agreed that Scott McKenna, Alicia Zeludko and Susan Tomlin consider a fair way to measure the tightness of all types of nosebands in consideration of the welfare of the horse and re present a new rule at conference to reflect this

## **REMIT 7:**

Submitted By: Scott McKenna (Technical Officer)

Re: Article 454: Lameness, Blood or Welfare Concerns Amend

Article 454 – Lameness, Blood or Welfare Concerns

- 1. Any horse that shows lameness while competing will be eliminated. The Judge or Chief Judge will ring the bell to stop the test and explain the reason for the elimination to the rider. There is no appeal form this decision.
- 2. (as per existing clause 3)
- 3. The Chief Judge may stop a test at any point and eliminate the rider if for any reason the Judge believes it is contrary to the best interests of the horse and/or rider to continue the test.

Clause 12 – Amend to

12. The rider has 45 seconds from the sounding of the bell to commence the test. The test commences from the point the horse proceeds on the centre line.

If the test is not commenced within 45 seconds of the sounding of the bell the rider will be penalised 2 points per judge.

If the test is not commenced within 60 seconds of the sounding of the bell the rider will be eliminated.

#### Amendment

Clause 15 – Amend to

A horse leaving the arena with all 4 feet between the time of commencement of the test and the time of exit from the arena will be eliminated. The only exception to this rule is when a horse is required to recommence a test pursuant to article 451(4).

It was noted by the NZPCA CEO that some venues simply do not have the appropriate facilities for stallions to be safely on the grounds and these events should not permit stallions to enter Alicia Zeludko noted any stallion handler must be capable and any grazing of horses should only be permitted in an enclosed area

Article 451 uses the terms "error of the course" and error of the test", neither of these terms are defined, but examples are given. It is proposed that the committee agree on comprehensive definitions of each of these terms.

It was agreed that Scott McKenna be given a mandate to discuss this further with the Judges Officer to compile a list of definitions

#### **TOPIC: VENUE FOR NZ DRESSAGE NATIONAL CHAMPIONSHIPS**

The Bay of Plenty delegate referred to the submission regarding hosting the nationals at Taupo NEC It was noted that the Board has recommended the Nationals will stay at Manfeild for 2019 but anticipates a move to Taupo in 2020. It is unsure when the NEC facilities indoor will be completed, particularly the kitchen and consideration for lighting if night shows are to be held.

#### **TOPIC:**

#### NATIONAL CHAMPIONSHIPS PLANNING 2019 and beyond

It was noted Celine Filbee has resigned from the position of national events manager effective Feb 2018 and that EOI are being sought for a replacement EM

The Sport Manager noted she had been invited to attend a Taupo NEC meeting in February which had been positive progress in understanding the NEC developments. Feedback around the facility following the Waikato RE had been well received by the Taupo committee.

#### **HOSTING A CDI 3\***

Riders /members had requested a breakdown of costs associated with hosting the national championships and /or a CDI in conjunction with a regional show. Comparative figures were presented from BoP and Waikato RE at Taupo NEC and the NCH at Manfeild. This demonstrated the differences with the NCH having a budget of approx three times the RE listed. Some points around the BOP RE budget were clarified. The Waikato Delegate noted their OC gratuities should be \$12,000 not \$1200, but that the total is correct

Sharon Field requested that EM payment to run the four day April show be reviewed and that she should not be underpaid for work done

#### **CALENDAR**

#### a) North Island Championships:

- The updated draft calendar for 2018/19 was tabled noting that Wairarapa have withdrawn from hosting NI Champs in 2019. Central Districts are hosting NI Champs 2018.
- A sub-committee comprising of delegates identified from areas who were identified as having suitable venues for NICH, Alicia Zeludko, Dana Haszard, Janine van der Horst, Debra Cowen, Karen Shields, Amber McGovern-Wilson & Rosanne Rix be delegated to investigate possible rotation and date setting in advance for planning purposes.

#### b) NZPCA & Dressage NZ

- Samantha Norman, dressage competitor and NZPCA CEO spoke to the meeting re difficulty of scheduling NZPCA /ESNZ dates to avoid clashes and the apparent short length of the season.
- Karen Shields noted that AMDG has a Young Rider event and suggested a joint venture with Pony Club Championships
- Scott McKenna asked if it was possible to "tag" PC Champs to a DNZ event
- **It was agreed** there is a need to work together where possible for the benefit of the development of dressage in both organisations

#### c) 2018/19 Calendar Draft for Review.


In 2013 Dressage NZ produced a set of tests which is still in use today.

  rider on request.



% in Levels







#### **UPDATE FOM THE JSC 24 MAY**

#### UPDATE ON TEST REVIEW AND USDF NEW TESTS: THIS IS A SERIOUS HALF HALT!!!!!!!

Unfortunately we still are no further ahead with viewing the new USDF tests and Australia has still not received them so until such time as we know exactly what is in each level we are "stalled" in our test review process. It is frustrating but it is essential we get this thoroughly looked over before we start changing things. I know many of you are concerned about some levels having difficult movements in them that "MAY" be of concern BUT we cannot speculate on what is or what is not in each level until we see them.

I do know that the US have spent many hours with senior qualified judges, riders and trainers going back and forth to make sure all levels are of the relevant standard and ask the correct questions. This is one of the reasons they are taking so long before they will release them to Australia.

Once Australia has them they will also review them with many of their top judges to make sure they will fit in with their training system. Once we have had chance to look at them in NZ we will certainly be putting together a small committee to review them, ie 2 riders reps, 2 trainers, JSC and hopefully our Sport Manager as she will be looking at administrative issues to go through. It will not be done without serious thought and the view to progress our sport, please be fully aware of that fact.

Once Australia have confirmed how they will use them and the levels then they will be sent over to NZ to look at and make sure they will fit our system. It is a huge lengthy process and many, many experienced people have gone through them to make sure they meet training scale, and challenges for each level that are appropriate for the confident training of horses to FEI level. I know many comments are floating around about the fact we must look after the grass roots riders and we certainly will be addressing that. No matter what your ambitions are the basic levels 0, 1 and 2 cover the correct basic way of starting off from grass roots and then continue to get a little more difficult depending on the training ability of the horse and rider......no one, and certainly not the JSC, is wanting to bring in new tests that our riders cannot cope with but in saying that we have to be more thorough in our basic training so that when combinations do go to the next level they are very confident in being able to execute the movements in that level. Again, remember no one has to go up to the next level either until they are confident and secure in the level they are at.

It could be that some riders may find themselves in the changeover period (especially from level 3 to 4) but I am sure with some sensible thinking we can overcome this in some way without losing the integrity of the tests.

It is very important we look at this very carefully as whatever happens these tests will stay in place for the next 4 years and probably won't be put into effect until 1st August, 2019.

It is imperative we all keep an open mind about this process and work together. I assure you all that as soon as I see these tests and Australia have worked them into their system I will send them out to all Areas for discussion. Any movement of judge levels etc will only take place at this stage of the process as we need to be committed to following the Australian system fully to be able to use tests, training videos, clinic literature, exchanging judges across the Tasman and making sure we have same levels in place as the Oceania system.

WORK COMMITMENTS FOR OUR FEI JUDGES AND ALSO EXCHANGE JUDGES IN THE NEAR FUTURE:

It is very exciting to know that our FEI judges have been working very hard internationally over the past year with invitations for the new season still coming in.

Also I would mention that Kristin Cottam (Southland) has just sat and passed her List 2 examination and will be part of our judge exchange scheme to NSW later this year. Travelling with Kristin will be Virginia Tocher (Waikato) – they will both judge at the NSW State Championships at SIEC in Sydney. Also on the exchange scheme we have Judith Cunningham and Judy Alderdice travelling to Boneo for the Young Rider Championships in Melbourne early 2019. It is hoped also that we will have an opening for two judges to Queensland also but this is to be confirmed at this time. We are also hoping to welcome an A Level judge from Melbourne to NZ – Mr. Adam Reese for the North Island Championships in Feilding and also two NSW exchange judges to Wairarapa Championships in January 2019. This exchange system is working well and is an essential tool for the training and development of our judges.

Other great news is we have had confirmation from Maja Stukelj (Slovenia – 4\*) that she will come to NZ early next year and be available to judge at SI Champs, Waikato Festival and also the Bates Nationals at Manfeild so it will be great working with Maja again. At this time also we are working on our International judges to invite to Bates Nationals and Horse of the Year 2019. We have sent out some invites and fingers crossed they can come. Once we get confirmation I will let you all know who they will be.

All for now but please keep an open mind on the test review until such time as we get to actually see the proposed tests that come in from Australia. We may be pleasantly surprised and it is so imperative we all stay focused on the positive.

These are mainly run, routinely, in the larger centres but can be also run privately if groups request this. The course is four hours long and costs \$70 per person (with the certificate valid for two years), but they also offer group discounts for 10 or more persons.

# **DISCIPLINARY**SYSTEM REVIEW

ESNZ has engaged sport lawyers Gibson Sheat to review and provide options to the ESNZ board for an updated disciplinary system.

The ESNZ board recognised that the current legal system was delivering well at competition level with sound Ground Jury and Appeal Committee processes. However, beyond that, the increasing number of complaints and issues that could only be sent to the Judicial Committee was going to require a different approach.

Gibson Sheat will be recommending an intermediate process which will be able to deal more quickly and efficiently with most disciplinary issues. More to come on this once the ESNZ board has received options. Gibson Sheat has also identified a number of issues and anomalies in the General Regulations, discipline rules and bylaws that will be fixed over time.

This review dovetails with the Constitution Review which requires an updated legal disciplinary system referenced in any new constitution. The constitution review will be part of a wide consultation process with all members.

It is important to note that ESNZ will be taking a hard line with behavioural issues that reflect badly on the sport in the future. A key change to our processes already in the General Regulations will see all official warnings made public on the website.

Officials and volunteers are urged to use the verbal and official warning processes at any events by discussing issues with the Ground Juries whenever they feel it is warranted. It will take a collective approach to delivering better behaviour in the arena and outside of it!

# AFFILIATED EVENTS AND INSURANCE

All affiliated ESNZ events that are run in accordance with ESNZ General Regulations, Discipline Rules and have a clear Health and Safety Plan are covered by our insurance. That means all ESNZ members (including casual) and ESNZ officials are covered by our policy while at ESNZ events.

From August 2018 any events that are not run by ESNZ area groups, the RAS or NZPCA will be required to be affiliated with ESNZ. This is so that any event can use the ESNZ rules, officials and disciplinary system, and so any ESNZ officials working at these events are covered by insurance.

All ESNZ officials must be financial members of ESNZ to be covered by our insurance (either full membership or non-competing membership). It will also be up to you to check online whether your sports day down the road has paid an affiliation fee to be able to use your services in a way that ensures you are covered by ESNZ insurance.

Events can sign up to be affiliated online at www. nzequestrian.org.nz and can be immediately affiliated for \$60.

If you are officiating overseas, FEI events will always be covered by the FEI's insurance, however, at non-FEI events overseas you won't be covered by FEI or ESNZ insurance. We are working on a way that we can help officials with this.



# OFFICIAL WARNING PROCEDURE - YELLOW CARD

ESNZ currently has an Official Warning Procedure whereby ESNZ officials can issue the warning for the inappropriate applicable behaviour/action. It is then filed with ESNZ and the recipient is sent a letter and it is added to their profile on the database.

The new website now has the functionality to log all warnings online. And the system will send the email automatically to the person, the issuing official and ESNZ.

# OFFICIAL WARNINGS ARE GIVEN FOR

- Abuse of horse
- Safety of others
- Incorrect behaviour
- Abuse/disregard of official
- Dangerous riding
- Non-compliance with rules

ESNZ officials will be able to log in, select which offence above applies and record it in the database against a member's profile\*. They will then receive notification and copy that they have registered the Official Warning.

All members will be able to see this information on the database when they are logged on (just as anyone can view the Yellow Card notifications on the FEI website).

Riders will receive notification of being given a warning card and will have to tick a box to say they have accepted the warning.

ESNZ admins will be able to run a report showing all Official Warnings, and will also be able to report by discipline.

Official Warnings will still be recorded with the date because if a rider receives more than one in a 12 month time period there are further consequences.

\*Training will be given to all Officials on how to record the Yellow Card warnings online.





# CONCUSSION AND SERIOUS INJURY BLUE CARD

One of the main jobs of ESNZ officials at events is keeping riders safe. ESNZ takes concussion injuries very seriously. We are doing a number of things to support officials in their job, particularly with respect to concussion.



Leading up to the start of the competition season later this year we will be providing information and training to all involved in equestrian sports to reduce the risks associated with concussion. ESNZ is supporting officials with our Blue Card process. We will continue to raise awareness by publishing information on concussion and the new policy in plenty of time before the start of the new season. There is also an opportunity for the disciplines to talk about this at their upcoming AGMs and conferences.

ESNZ has been working with Dr Stephen Kara of Axis Sports Clinic to finalise a Concussion policy for use in ESNZ competition. Information will be provided at the disciplines' AGMs in June and July and training for officials will be provided by Dr Kara in conjunction with ESNZ's AGA on 8 October (see AGA Workshops and Training). The workshop will cover the Concussion policy, the role of ESNZ officials with respect to the policy and its implementation (the Blue Card process) and what symptoms to look for with suspected concussion.

# THERE ARE THREE KEY STEPS IN RECOGNISING AND MANAGING CONCUSSION INJURIES:

- Recognising the signs and symptoms of concussion and seeking urgent medical treatment if required
- Removing the person from the event
- Returning to competition

#### RECOGNISING THE SYMPTOMS

Officials have an important role in observing possible concussion and its effects (e.g. behaviour/symptoms) and should take responsibility for removing the injured rider from the event. In cases of uncertainty always adopt a conservative approach – If in doubt sit them out.

Concussion can occur when a rider receives an impact to the head or body that causes the brain to shake inside the skull, so is not necessarily caused by direct impact to the head. If a rider is knocked out or loses consciousness they have obviously sustained a concussion, but it is important to remember that a person can be concussed without losing consciousness.

The Concussion Checklist is an essential tool for determining the signs and symptoms of concussion. ESNZ has a supply of these pocket-sized checklists and can provide them on request or you can order them direct from ACC https://accsportsmart.co.nz/home/resources/

#### To help an unconscious rider:

- Apply first aid principles DRSABC (Danger, Response, Send for help, Airway, Breathing, Circulation).
- Treat all unconscious riders as though they have a neck injury.
- An unconscious rider must ONLY be moved by a medical professional trained in spinal immobilisation techniques.
- Call 111 if you are concerned about the risk of head or nect injury as urgent hospital care is required.



Immediately after a fall, the rider may feel completely fine, as concussion symptoms may take hours or days to appear. When a rider gets back on to ride or compete with a concussion, they put themselves at unnecessary risk of suffering from another blow that could cause devastating, life changing consequences.

### **REMOVE FROM THE EVENT**

Riders who are concussed are often unaware of their symptoms and may want to continue riding. It is imperative that the Ground Jury at the event takes responsibility for the rider's wellbeing, assesses the rider and make an informed choice about whether the rider should continue to ride or not – if any doubt the rider must be removed from the event as per the Blue Card process.

In order to help limit the risk of re-injury soon after a concussion, ESNZ's Blue Card process has been developed to keep riders safe and to support officials in their duty of care:

#### **General Regulation 150:**

- 1. The Ground Jury may at any time exclude from further participation in a competition or an entire event any rider who is deemed unfit to continue by reason of a serious or potentially serious injury, impairment or health condition. Medical clearance to compete again must be given by a registered GP or registered medical specialist.
- 2. If a concussion or serious injury is suspected by a member of the Ground Jury at the event, the rider should be immediately removed from participating and be issued with a Blue Card concussion note\*\*. A Blue Card means that a rider is stood down from all riding activities until clearance from a registered GP or registered medical specialist can be obtained. A copy of their Blue Card will also go straight to ESNZ, which will then go on that rider's profile.
- 3. If a rider issued with a Blue Card at an event refuses to withdraw from the event, this may result in disciplinary action taken through the disciplinary process set out in the ESNZ general regulations.
- 4. All riders who have been withdrawn from competition due to a suspected concussion are required to provide ESNZ with a medical clearance note from a registered GP or registered medical specialist before they are able to compete again. Once this has been received the Blue Card will be withdrawn and removed from a rider's profile.
- 5. If a rider who has been issued with a Blue Card competes without first providing medical clearance, this may result in disciplinary action taken through the ESNZ disciplinary process set out in the ESNZ general regulations.
- \*\*ESNZ will give training to Officials on how to lodge a Blue Card on our website

Even if there are no immediate symptoms of concussion these can show up later, so it is important to keep a close eye on the rider.

Make sure the rider has a 'buddy' (parent/guardian/family member/friend) who will ensure they are monitored, not left alone for the first four hours and will get the rider home safely. Riders with a suspected concussion should not drive a motor vehicle.

Give a Concussion Checklist to the rider and their buddy/guardian so everyone knows what to watch for over the first 24 - 48 hours.

Concussed riders must get urgent medical treatment if they show signs of:

- Worsening headache
- Increased drowsiness or can't be woken up
- Vomiting
- Increased confusion or agitation
- Weakness in any limbs
- Slurred speech
- Loss of consciousness or seizure.

Returning to competition

Riders should not return to riding until symptom free AND medically cleared (as per the ESNZ Blue Card process above).

If a rider returns too soon, while symptoms are still present, it will slow recovery and put them at risk of further concussions.

If a rider sustains a second concussion before the previous one has fully resolved the impact will be more severe and can in some instances be fatal.

# **DRUG FREE SPORT -** ATHLETE TESTING NEXT SEASON

Both Drug Free Sport NZ (DFSNZ) and FEI have indicated to ESNZ that they will increase athlete drug testing in the 2018/2019 season.

"It is vital that everyone participating in equestrian sport fully understands the importance of clean sport and the rules they must adhere to, at both national and international level," said ESNZ's General Manager Dana Kirkpatrick.

The rules apply to both human and equine athletes.

Officials play an important role in promoting the clean sport message and in helping to educate riders and their support people.

Testing of horses and riders can take place at both National and International competitions. National competition testing in New Zealand is carried out and governed by Drug Free Sport NZ. The FEI Code governs FEI events. Horse and rider testing can take place at any FEI event, any time.

Dana urges all riders to familiarise themselves with banned substances.

"Things you might never suspect as being on the banned substance list or ingredients in what you might consider harmless supplements often catch people out," she said.

There are excellent DFSNZ anti-doping e-learning courses and resources available and ESNZ urges all involved

ESNZ has athlete testing booklets and wallet cards in stock to give out as applicable.

# THERAPEUTIC USE EXEMPTIONS (TUES)

TUEs will often be granted for certain controlled medications if taken for medicinal purposes and supported by the athlete's GP or health specialist.

For National testing, TUEs can be granted and approved retroactively, however, for International testing, retroactive TUE applications will not be accepted and therefore all TUE applications must be submitted for approval before the athlete competes with the medication in their system.



It would be good practice for those not competing in FEI competition to also submit TUE applications to DFSNZ before competing.

#### THE PROHIBITED LIST

Supplements such as protein shakes, pre-workout shakes, energy drinks, herbal remedies or vitamins continue to be an issue for NZ athletes.

#### From DFSNZ

No supplement is 100% safe, however batch tested products are the lowest risk. Be aware that batch tested supplements do not provide a guarantee against testing positive.

Supplements can be accidentally cross contaminated by other substances made in the same factory, or can be deliberately spiked by the company to ensure users get results.

Many supplements have inaccurate labelling. Ingredients can have more than 20 different names and not every version is listed on the label. Labels may also fail to list every ingredient or refer to "proprietary blends" where ingredients are not specified. Many studies suggest there is little evidence that athletes need supplements given a well-balanced diet.

Most recreational drugs are prohibited in sport and many are stored in the body for an extended time period. Use of them is taking a great risk.

#### DANGERS OF DOPING

Doping is a concern beyond being against the rules of sport. There are risks associated with using supplements, as well as the health consequences associated with specific substances (including steroids, EPO, stimulants, hGH, masking agents, marijuana and narcotics).

# GROUND JURIES FOR EVENTS

Some of our sports' smaller events often run without Ground Juries which negates any disciplinary process for competitors should it arise.

It is important that competitors have access to a disciplinary process at any ESNZ event where points or qualifications towards Championship Events, HOY, etc can be gained. At the very least two Ground Jury members need to be in attendance.

# FEI OFFICIALS

# EXCHANGE PROGRAMME

ESNZ officials are encouraged to apply for a new FEI Officials Exchange Programme which is available for all FEI officials in all FEI disciplines.

The exchange programme enables FEI officials to gain experience through officiating at events on a higher level than those available in their own country. The programme will help National Federations and FEI officials to get access to international events and to be an official member of the respective discipline team of officials.

FEI officials will be able to access financial contributions for travel, accommodation and other related expenses.

# **GENERAL REGULATION**

# **CHANGES**

There will be several important changes to the ESNZ General Regulations on 1 August 2018.

#### Article 144: Complaints/Appeals

144.4. Complaints must be in writing signed by the complainant and lodged with the General Manager of ESNZ together with a deposit of \$500. Part of this deposit may be refundable, to be decided on by the Judicial Committee after the hearing.

#### **CHAPTER SIX: HORSES**

# Article 127: Age Definition and Classification of Horses and Ponies

- 1. The minimum age for any horse entered in any event will be determined by the Discipline Board.
- 2. To compete as a pony in competitions under the Constitutional Rules and Regulations the pony must measure 148cm or under. The person responsible must be in the possession of an annual or life measurement certificate issued by the Royal Agricultural Society for that pony. A copy of this must be lodged with ESNZ on the pony's file to complete the process.
- 3. Classification of the height of a pony is up to and not exceeding 148cm. Once a pony is registered with ESNZ it may, if its height changes, be re-registered as a horse. However, once re-registered as a horse it cannot be registered again as a pony.
- 4. Classification of a horse is height over 148cm. Once a horse is registered with ESNZ it may, if its height changes, be re-registered as a pony, provided it has a current RAS height certificate or life certificate. However, once re-registered as a pony it cannot be registered again as a horse.

#### 150. Officials and concussion rules

- 7. The Ground Jury may at any time exclude from further participation in a competition or an entire event any athlete who is deemed unfit to continue by reason of a serious or potentially serious injury, impairment or health condition. Medical clearance to compete again must be given by a registered GP or registered medical specialist.
- 8. If a concussion or serious injury is suspected by a member of the Ground Jury at the event, the rider should be immediately removed from participating and be issued with a Blue Card concussion note. A Blue Card means that a rider is stood down from all riding activities until clearance from a registered GP or registered medical specialist can be obtained. A copy of their Blue Card will also go straight to ESNZ, which will then go on that rider's profile.
- **8.1.** All riders who have been withdrawn from competition due to a suspected concussion are required to provide

ESNZ with a medical clearance note from a registered GP or registered medical specialist before they are able to compete again. Once this has been received the Blue Card will be withdrawn.

**8.2** If a rider who has been issued with a Blue Card competes without first providing medical clearance this may result in disciplinary action taken through the ESNZ disciplinary process set out in the ESNZ general regulations.

# Article 153: Minimum Standards for Medical Personnel and Services at National Federation Events

- 1. Prior to the event Organising Committees:
- 1.1. Must notify the Regional Ambulance Control Room for that area of the date and location of the event and explain the potential accidents that can occur at such an event.
- **1.2.** Should provide a centrally sited medical station with contact details of the nearest A&E or after hours GP.
- 1.3. Should ensure that there is good access to all parts of the course.
- 1.4. Should provide a good system of communication to and from all parts of the course and to emergency services
- 1.5. Must have an agreement in place with the venue/ property owner as to the official take over times for the venue and who is responsible in case of an emergency before the competition begins and after it finishes.
- 2. During the event:
- **2.1.** A doctor or an ambulance staffed by an Ambulance Officer must be available within 30 minutes of being called.
- **2.2.** A holder of a first aid certificate must be on the grounds at all times during competition hours with appropriate first aid kit/gear.

All events must also comply with discipline safety and medical rules as set out in the discipline rules.

# Annex a: minimum standards for esnz approved portable yards

The use of ESNZ approved portable yards at events is by permission of the Organising Committee. If portable yards are not allowed to be used this should be advertised in the event schedule.
