**Clinic Date:**

Friday 2<sup>nd</sup> October - Sunday 4<sup>th</sup> October 4pm.

**Venue:**

Taupo NEC (Indoor/Outdoor)

**The Clinic:**

The clinic will include mounted and unmounted workshops and live demonstrations covering a range of topics from horse/pony management, riding skills and development, sportsmanship, rider fitness, social media and competition preparation.

**Selection process:**

Applications are collated by the NI Pony and Young Rider Convenor, to ensure applications are complete.

Applications are then forwarded to Dressage NZ Selectors.

Application to attend does not infer right of attendance.

**Successful applicants will be notified by 10<sup>th</sup> August and will be provided with additional information including camp costs**

**Successful Applicants Clinic Payments:**

Payments are to be made within 14 days of notification of acceptance into the clinic.

**Fees:**

Riders are responsible for their own travel and any accommodation, yarding/stabling costs for the clinic.

**Clinic fee:**

As this year we are going to be catering for more riders, some of which are unmounted, we are still working on the budget. The Clinic fee will be advised once applications have closed. The unmounted fee will be less than that of mounted.

**Please note all yard and camping booking must be made through the camp convenor and payments included with the camp fee. A booking form will be sent to successful applicants**

**NEC Fees per Clinic:**

Facility Fee @ \$30 per horse

Covered Yards @ \$75 per horse

Camping per truck @ \$30

Portacabins @ \$40 for two nights (depending on availability)

Rider meals are included in the clinics cost, other family and/or persons responsible will pay additionally

**Withdrawal From Clinic:** If a rider is unable to ride they may join the camp as a unmounted rider. If a rider wants to withdraw from the camp completely an application form for a refund will be required for a refund. Any withdrawals should be made as early as possible to enable reserve riders to attend
