KEY INFORMATION FOR COMPETITORS & PERSONS RESPONSIBLE:

1. It is the responsibility of the rider, person responsible and /or person making any entry to have read and understood the conditions & rules for this event as published in this schedule.
2. Competitors should note for the purposes of communications at the event, that Vodafone coverage may be limited and the OC requests that competitors using Vodafone to remain aware of this during the event.
3. Official Event Start Time: 9am Thursday 23^d November 2023

This is the start time for the period of jurisdiction for all FEI, Equestrian Sport New Zealand (ESNZ) General Regulations, Veterinary Regulations and ESNZ Dressage rules and ESNZ policies including Code of Conduct.

4. Restriction on Entry into Grounds:

There is no competitor access to the grounds prior to 9am 23rd November. Horses (other than CDI-W, CDI-3* and CDI-Y horses) must not be ridden on the grounds before 12 midday on 23rd November. These conditions will be strictly enforced and failure to comply will result in disqualification of all entries from that rider from any further participation at the event.

Arenas:

Warmup areas will be open for schooling from 12 midday to 3.30pm Thursday 23rd November.

Arena Familiarisation will take place from 4.00pm-4.45pm pm Thursday 23rd. Please check rider notices for further details on familiarisations.

Competition is expected to commence 8.00am Friday 24th November.

5. Rider Welcome and Briefing Thursday:
6.30pm Thursday 23rd November in the VIP Marquee. All riders are encouraged to attend.

HEALTH AND SAFETY:

ESNZ Dressage is committed to providing and maintaining a safe and healthy event for all participants, and to providing the information, training and supervision needed to achieve this.

1. All competitors and visitors to the venue must abide by the ESNZ/Dressage NZ and Takapoto Estate Health & Safety Policies and the Health & Safety at Work Act 2015.
2. Copies of the event Health & Safety policy can be found at the event office.
3. Any incident or near miss must be reported to event office and incident form completed.
4. Any hazards identified must be reported to Event Office or a steward as soon as practicably possible.

PROFESSIONAL SERVICES

1. Equine Therapists and Treatment

- a. Qualified equine therapists or practitioners who are not veterinarians and intend to provide therapeutic treatment to equines in any capacity at this event in a private or commercial basis must seek permission to practice and sign in at the event on arrival. And notify the Organising Committee of any treatments on the form provided.
- b. All practitioners must also comply with the Conditions applicable to this event set out in the Schedule of classes.
- c. Riders who own their equipment are only permitted to treat their own horses with these systems at the event according to FEI rules.
- d. Any practitioner receiving financial or other gain from providing therapies at the event may be required to pay a trade exhibitor fee at the discretion of the Organising Committee.

2. Other Professionals / Traders

Any other professional intending on providing services or trade of any kind at this event must obtain prior agreement from the Organising Committee – this excludes professional Dressage Coaches assisting in the warmup of competitors and grooms that are in part or full-time employment of a competitor.

RULES & EVENT CONDITIONS SUMMARY:

This must be read in conjunction with ESNZ Dressage Rules effective from 1/9/23.

1. **Rules:** All competitions will be run under the current version ESNZ GR's, VR's & ESNZ Rules for Dressage with particular reference to the following - which should not be read as the complete set of rules applicable to the event. The absence of a particular rule in this list does not denote it does not apply.
2. **Prohibited Saddlery:** ESNZ Dressage Rule 420-430: Prohibited gear is not permitted from the time of arrival at the venue.
3. **Riding Helmets:** ESNZ yellow-tagged, approved riding helmets must be worn at all times when mounted at the venue.
4. **Horse/Pony ID Numbers (DR Art 429):** Approved Horse/Pony official identification numbers must be worn on both sides of the horse/pony at all times during warm up and competition, and when being ridden or led in arena familiarisation. ID Tags with Horse Name, Rider name & phone contact must be worn in or out of the stable/yard at all other times.
5. **Schedule Amendments:** The OC reserves the right to alter the programme/schedule and/or prize money within the ESNZ GR's/ESNZ Dressage NZ Rules.
6. **Prize Money: DR article 481 & Under Special Conditions Art 407.** The OC reserves the right to adjust the advertised Prize Money. The OC reserves the right to amend/limit the number of prizes or prize money if less than eight starters in any class. Up to 3 starters, 1st only; 4-5 starters 1st & 2nd; 6-8 starters 1st – 3rd; 9 or more 1st - 4th, and/or pay prize money which is less than the entry fee for 1st - 4th place getters. The OC reserves the right to present product or prizes in lieu of prizemoney.



7. **Equal Placings: (DR Art 480)** In the case of equality in any class at this event, the higher collective marks will determine the higher placing. If the competitors are still equal, then the higher co-efficient marks will determine the placings. If there is still an equality of points, the competitors are given the same placing.
- Equal Placings CDI-W, CDI 3*, CDI-Y (Ref FEI Rules). In the case of equality of percentage for the first three (3) places, the highest total median score of the Judges will decide the placing. The median score is the middle number. To calculate the median of a set of scores, the scores need to be put in ascending numerical order. E.g., 68.5% - 69% - 70% - 70.5% - 71%; 70% is the median score in this case.
 - Ties in Freestyle: In the case of equality of percentage in a Freestyle Test for the first three (3) places, the higher artistic marks will decide on the better placing. Should the artistic mark be the same, the higher mark for harmony will decide. If still tied the higher mark for choreography will decide.
8. Music for all Freestyle Classes.

Music Upload. All riders must upload their music to EvoEvents for their freestyle by 15th November 2023. A wav. file is the preferred format (best quality) however an mp3 file is also acceptable. Note: This upload is event specific so you will need to upload to this event even if you have uploaded to a previous event.

Procedure on EVOEVENTS

- Select the event.
 - Click the 'More' button.
 - Enter a description for the music.
 - Select the file type called "Music for MFS".
 - Select the class and horse.
 - Select the file to upload from your own computer.
 - Press the 'Upload Your Document' button.
9. **Presentation of Prizes:** Approximate presentation times will be advised in the programme and are subject to change at any time, please check with event administration for updates. The Organising Committee reserves the right to withhold prize monies or prizes/trophies should a place getter not attend an advertised prize giving. Only Riders with conflicting classes may nominate another person to the Prize Giving Co-ordinator to collect prizes/rosettes at the prizegiving.
10. **Media & Publicity:** ESNZ Dressage NZ reserves the right to use event photographs for marketing, publicity, advertising, funding applications and other promotions as they see fit. ESNZ Dressage reserves the right to record and broadcast via live stream or any other type of digital broadcast any or all of the competition at the ORO Dressage by the Lake 2023 competition, both during and after the event. Competitions and/or participants will receive no remuneration for this. All footage remains the property of ESNZ Dressage. The copyright of all photographer's work must always be respected by competitors and their associates during and after the event and may not be used without permission of the photographer.
11. **Commanding:** No tests may be commanded in Arena 1.



GENERAL VENUE CONDITIONS

Dogs

1. Dogs are not allowed onsite unless they are certified support dogs (who must have prior approval).
2. Riders will be disqualified from the event if they or any member of their support team breaks this rule.

Vehicles

1. Truck entry by middle gate only on Finlay Road
2. There is no vehicle access or parking around the arena area except for accredited officials and service vehicles. All other visitors must park in designated car parks. The OC reserves the right to limit parking in vicinity of the stables to horse transport vehicles only. No cars are permitted in the FEI stable area.
3. The speed limit for all vehicles is 15 kph in all locations.
4. Motorbikes must not be used before 6.00am or after 8.00 pm and must be used in accordance with normal road rules. Approved safety helmets must be worn when riding motorbikes at all times. Persons under 16 years may not use a motorbike.
5. Safety helmets must always be worn by all people on a push bike.
6. No e-scooters are to be used in any horse area.

Stables and Parking Area

1. All stables are of portable construction.
2. All horses must be in stables. No horses are to be tied to trucks at any time.
3. The OC will endeavor to keep horses from the same rider, team, or family together on request, but this is not guaranteed. FEI horses will be confined to FEI stable block as per FEI rules. National horses accompanying FEI horses will be allocated stabling at the discretion and direction of the FEI Vet Delegate. This will be advised after entries have closed.
4. All Stables are supplied with shavings, and there will be additional shavings available (loose) which can be added to stables. Riders are also welcome to purchase additional HERDD bedding direct from ORO Equestrian to be delivered to their stables prior to arrival.
5. Moving horses to stables not prior allocated to those horses is prohibited without permission of the Stable Manager
6. No use of temporary yarding is permitted.
7. All yards and stables are to be left clean, free of all horse waste & hay. \$100 administration and cleaning fee will apply if NOT left cleaned to the satisfaction of the OC.
8. All stable muck to be disposed of in nominated areas, please use the wheelie bins provided for rubbish only and do not leave rubbish in the muck heaps.
9. Keep wash down bays clean at all times.
10. No smoking or vaping in any buildings or stable and yard areas.

Camping & Power Sites

1. Parking areas may be defined. Some areas may be restricted to on-site camping/parking only.
2. All competitors must follow Officials directions and restrictions on parking.
3. Trucks and Campervans will be allocated specific powered sites and must have a valid electrical certificate and under no circumstances may permit other vehicles to connect to their vehicle via extension cords.



4. No emptying of waste and grey water tanks allowed onsite.
5. Please be tidy and use appropriate bins for all rubbish.

ENTRY CONDITIONS & PROCEDURES

1. Eligibility is the responsibility of the person responsible, competitor or person making the entry.
2. Fees: Payment of all fees is required at time of entry. Entries are not considered to be definite until payment has been made. Payment at time of entry is the responsibility of the person making the entry, NO payment reminders will be issued by the OC.
3. Entries will be accepted in order of entry – entry is not confirmed until full payment is made. Underpaid entries will be placed on the wait list.
4. All competitors must be current ESNZ full or child members current until 26th November 2023 at the time of entry.
5. All ESNZ horse/pony registrations must be current to 26th November 2023 at the time of entry.
6. FEI Entries: CDI-W, CDI-3* and CDI-Y: Please ensure FEI horse and rider registrations are valid for 2023 by 1 November to enable FEI entries to be loaded into the FEI entry system by the OC. FEI horse passports must be valid. Horses require passports for the CDI-3* & CDI-W. Recognition cards required for CDI-Y
7. All FEI tests are current versions as per the FEI Website
8. If any class is oversubscribed, further entries will be put on a waitlist. Any combination on a waitlist who does not get a start will receive a refund less Evo Event fees.
9. All horses/ponies other than those competing in Para-Equestrian classes must have a current annual dressage start or pay flexi start fees per Dressage NZ Rules: Art 401-408.
10. Only entries received at www.evoevents.co.nz by 8pm 1st November 2023 with all fees paid will be accepted. Payment can be made by Poli-Pay. Credit card payments will attract a card transaction fee. NO Postal, fax, emailed or phone entries accepted.
11. Entry Changes: Changes can be made to entries at no charge until 10th November. Any requests for changes after 10th November may be made but will be subject to the approval of the OC. A fee of \$25 per class will be applicable if approved.
 - a. Upgrading: Must be notified to the Entry Secretary within two working days of the horse upgrading and changes requested on EvoEvents. Failure to do so prior to the event will result in no refund and additional entry fees charged.
12. Combinations may accrue points for the Prestige Futures Prize, AMS Performance League, and Dressage NZ Top 10 Leagues.
13. Horses not Entered: All horses and ponies on the grounds at any time must be entered at the event unless special permission is granted by the OC. Requests must be made by email to the Event Secretary before 10 November 2023 to be considered. Companion horses granted approval to be on the grounds will not be permitted to be ridden or schooled in any arena and must have appropriate ID tags on at all times.



ENTRY CONDITIONS

1. Dressage NZ reserves the right to restrict the number of horses/ponies at the event by restricting entry numbers. Numbers per level in principle are:
 - i. Preliminary - Novice 25 horses/ponies per level;
 - ii. Elementary – 23 horses/ponies
 - iii. Medium – Advanced Medium 20 horses/ponies per level;
 - iv. Advanced – Small Tour 20 horses per level;
 - v. Para-equestrian 10 horses;
2. Dressage NZ reserves the right to change numbers of horses accepted per level.
3. Waitlists will operate for all levels. Riders entering waitlist classes will be charged all admin, stabling and other fees on entry. These will be refunded should the rider not be accepted into the main class listings
4. Horses & ponies may only compete at one level.
5. Downgraded combinations are eligible to enter.
6. Combinations may only compete in Para Dressage Classes or Dressage Classes for the duration of the event, not both.

FINALS CLASSES

Finals classes will be run on Sunday.

Preliminary-Medium grades will be restricted to approximately 15 horses qualifying per level, based on average percentage from all tests on Friday and Saturday.

Preliminary Horses not qualifying for the Final class will be scheduled to start in the Consolation Class, allowing all Preliminary horses a start on Sunday (and therefore 3 classes for the show).

Riders will be required to pre-pay for the Finals classes at time of entry. Refunds for combinations not accepted will be made after the event.

Riders who do not pre-pay for the Finals classes at time of entry will not be eligible.

A full list of combinations qualifying will be published by 6pm Saturday.

Riders will be required to accept nomination for Finals classes by 7pm Saturday at the Event Office to confirm start.

A waitlist will operate for the next 3 combinations, acceptance onto the waitlist will close also at 7pm Saturday, and announcements of the final starting order on Sunday will be confirmed by 9pm.



REFUND POLICY EVENT CANCELLATION

Should force majeure or circumstance/s beyond the control of ESNZ Dressage result in cancellation of part or all of the event, refunds will be applied as follows:

1. Cancellation of show before close of entries - full refund of all class entry fees, and ground, and stabling fees. No refund of Admin or EVO Event Fees
2. Cancellation notified after close of entries but on or before 10 November - full refund of all ground and stabling fees, 50% refund of class entry fees, no refund of Admin or Evo Event Fees
3. Cancellation notified after 10 November but before 20 November - full refund of all ground and stabling fees, 25% refund of class entry fees, no refund of Admin or Evo Event Fees
4. Cancellation notified after 20 November— any refund at discretion of OC.

DRAW

Draw will be available by email and web site www.evoevents.co.nz

Multiple Horses: Riders with more than 2 horses: The OC will make every effort to ensure that riders have at least 60 minutes between tests. However, if this is not possible owing to the scheduling of classes, the maximum time possible between tests will be allocated.

Daily Draw: If required, a revised draw and/or start times for the following day's competition will be available by 6.30 pm at event administration office and updated online.

Sunday Draw (Final classes Preliminary – Medium levels): Class times will be scheduled for these classes prior to the show. A full list of combinations qualifying will be published by 6pm Saturday, with acceptances closing at 7pm. Final starting order for Sunday will be confirmed by 9pm Saturday.

The OC reserves the right to alter the draw/programme to ensure the smooth running of the event.

It is the rider's responsibility to check for any new times posted.



WITHDRAWALS & REFUNDS

Scratchings must be notified by email or via Evo Events.

1. There will be no refunds of any fees if withdrawal is not notified to the Event Secretary prior to the commencement of competition on the first day the horse or pony is scheduled to compete.
2. All applications for entry fee refunds after 14 November must be accompanied by a current Vet Certificate or Dr Certificate for refunds of Class Entry Fees
3. A Vet Certificate is only valid for the horse stated on the Vet Certificate and does not qualify refunds for other horses entered by the same rider or person responsible. Vet certificate must be dated and cover period of competition.
4. Other applications for refunds may be considered at the discretion of the OC.
5. Refunds will be made no later than 31 December 2023
6. Refunds will be applied in the following manner:
 - a) Scratchings notified before close of entries:
 - a. Full refund of all class entry fees, and ground and stabling fees
 - b. No refund of Admin Fee or EVO Event fees
 - b) Scratchings notified after close of entries but before 14 November:
 - a. Full refund of all ground and stabling fees
 - b. 50% refund of class entry fees on provision of vet or doctors' certificate
 - c. No refund of Admin Fee and EVO Event Fees
 - c) Scratchings notified after 14 November but before 21 November:
 - a. Full refund of all ground and stabling fees
 - b. 25% refund of class entry fees on provision of vet or doctors' certificate
 - c. No refund of Admin Fee and EVO Event Fees
 - d) Scratchings notified after 21 November:
 - a. Refund by application and discretion of OC

2. All competitors must be current ESNZ full riding or child members current until 26 November 2023 at the time of entry.
3. All competitors must have current ESNZ Para-Equestrian Classification.
4. All horse registrations must be current to 26 November 2023 at the time of entry.
5. ESNZ, Dressage NZ & ESNZ Para-Equestrian rules apply from time of arrival. Official event start time as stated in this schedule.
6. Combinations may only compete in Para Dressage classes or Dressage classes (using permitted compensating aids) not both.
