Special Conditions

- a) To start all riders must have current ESNZ membership
- b) Unregistered horses in classes 4 to 7 may start on a casual ESNZ Equine Registration of \$5 per horse.
- c) Unregistered horses, or horses with no eventing discipline start, may start in classes 4 or 5 with an Eventing Flexi Start of \$15 per horse.
- d) Food and farrier available on grounds.
- e) Committee reserves the right to alter the programme and prize money, and to substitute prize money with goods to the value of, at their discretion Article 611.
- f) No non competition horses on the grounds at any time.
- g) As a condition of entry all local BOP riders must supply a helper prior to or during the event.
- h) All classes part of ESNZ Eventing National Series Competitions.
- i) Classes 2 and 3 run under FEI Eventing Rules, other classes run under ESNZ Eventing Rules.

ROTORUA A&P ASSOCIATION GROUND RULES

- 1) All horses to have a yard. NO HORSES TIED TO TRUCKS OR FLOATS unless saddling up.
- 2) Dogs to be on a lead at all times. No dogs allowed on Ngati Whakaue Land. Fine/Elimination if these rules not adhered to.
- 3) No unauthorised motorbikes on the grounds.
- 4) No person under the age of 18 may consume alcohol on the Rotorua A&P Association grounds.
- 5) All Yards are to be left in a clean tidy condition. If your yard is left dirty you will be fined \$50
- 6) <u>Under NO Circumstances is Dung or Hay to be put over the fence into the River Reserve. This will compromise the</u> future use of the grounds. The council has imposed a \$10,000 fine for this offence.

Timetable In order to accommodate everyone we reserve the right to run all phases of some classes on one day. Otherwise Dressage and Showjumping Saturday, Cross country Sunday.

Prizes can be collected from the secretary's office 30 minutes after results are signed off by TD.
