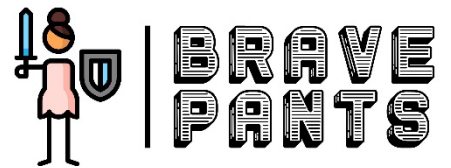

Current Rule:	2.5 All fence heights at H.O.Y. will be set at maximum or according to ground conditions.  2.6 Courses at H.O.Y. should have at least one change of direction and at least one combination of 1 or 2 strides , there should be 8 – 10 fences.		
Proposed Rule Change:	Delete 2.5 and 2.6		
Rationale:	Now that SH has official course designers that are trained to design courses appropriate to the level of competition these articles are not required to be in the rules. They date back to the time when there were no official course designers.

Proposed Rule Change:	5. Adult Riders riding Ponies Adult riders, aged 17 years and older, may ride ponies at Introductory events (i.e. events that DO NOT have HOYQ classes) but will not be eligible for prizes, ribbons or points.		
Rationale:	It is needed to very clear that an adult cannot ride a pony in an Introductory class at an event that also has HOYQ classes.

Proposed Rule Change:	Replace with – Adult riders, aged 17 years and older, may ride ponies at Introductory events (i.e. events that DO NOT have HOYQ classes) but will not be eligible for prizes, ribbons or points.		
Rationale:	This is so the wording for B5 and this rule are identical.

Rationale:	This is updating the rule to reflect the new terminology now used for judges.

Rationale:	Disobedience is replaced by refusal. In SH a disobedience is when horse kicks out, naps etc.

Current Rule:	3. The following will result in elimination: <ul style="list-style-type: none"><li>• Three refusals or disobedience on course.</li></ul>		
Proposed Rule Change:	3. The following will result in elimination: <ul style="list-style-type: none"><li>• Three refusals <del>or disobedience on course</del></li><li>• Resisting for 45 continuous seconds once an equine has entered the competition ring.</li></ul> And add another bullet point		
Rationale:	Elimination for disobedience on course has been removed because in SH a disobedience can be a kickout or napping and this results in a low score but not elimination.  Elimination for resisting for 45 continuous seconds is a Jumping rule and it needs to be in the SH rules as judges use this rule and riders need to be aware of it.

Current Rule:			
Proposed Rule Change:	<p><b>Add Point 9</b> 9. The competitor's round is deemed to have commenced either: - When the competitor enters the competition arena after the gate keeper has communicated the number/name of the competitor to the Judge via radio OR – in the case of no radio contact between gate and judge, when the competitor gives their name/number to the judge The competitor's round is deemed to have finished when the competitor exits the arena.</p>		
Rationale:	<p>In jumping, the competitor's round is deemed to have started when they pass through the start flags and finished when they pass through the finish flags. There being no flags in Show Hunter, there is a grey area around the start and finish of a round of a round. Therefore, it is necessary to define when a round starts and finishes.</p>

## H. Equipment for Show Hunter

### 1. Equipment Allowed List

- A bridle, with an allowed bit, that may have a correctly fitted cavesson noseband above the bit.
- Any form of snaffle bit where the action is on the equine's mouth, including corners of the mouth, bars, and tongue (it is the competitor's responsibility to check with an SH official to confirm the bit they use is allowed, as some bits have 'poll action' and are not allowed). A snaffle bit is where the cheek piece and the rein are correctly fitted to the same ring and can move freely.
- Pelham bits if used in their entirety (with a correctly fitted chain) where the primary action is on the equine's jaw. Must be used with either two separate reins or joiners or forked reins.
- Kimblewick bits, with a correctly fitted chain. If a slotted version is used reins must NOT be attached to the slots.
- Leather blinker cheeks that are permanently attached, maximum width 2cm.
- Spurs that are non-rowel and have smooth sides. Spurs that have a smooth rolling ball. Spurs that have a rolling ball that is flattened top and bottom, min thickness 7mm.

## FROM THE JUMPING RULE BOOK:

### CHAPTER I: THE JUMPING EVENTS

#### Article 200 - General

9. Horses and ponies must be a minimum of 4 years to compete in jumping competitions, to a maximum of 1.10m.

## CHAPTER VII: ELIMINATIONS, DISQUALIFICATIONS, FINES

### Article 240 – Fines, Verbal & Official Warning Cards

1. The President of the Ground Jury may impose fines and official warning cards, **the Chief Steward and the President of the Ground Jury may impose verbal cautions**, in accordance with the General Regulations in the following cases:
  3. Official warning card – Refer to General Regulations Art. 143.
    - 3.1 **All Verbal Cautions will be recorded.**

### Article 256 – Dress, Protective Headgear and Salute

**1.10. Comb spurs are not allowed.** Rowel spurs, that is spurs with a notched, or serrated rotating disc are not authorised anywhere within the grounds of Jumping Events; spurs with a rotating disc that are not notched or serrated are allowed. The Athlete may wear only one spur on each boot. The spur must point to the rear with the shank directed downwards. No tape or other material on any part of the spur is allowed.

For Ponies only - Non serrated rowel spurs must be at least 3mm in thickness **and no more than 4mm in length.** **Serrated rowel spurs must never be worn. Blunt spurs are allowed.** (Art 243 and Annex 9).

**Not allowed**



## Article 257 - Saddlery

- 2.1. In the interests of safety a saddle must be worn in the competition and warmup arenas. The stirrup iron, and the stirrup leather (this also applies to safety stirrups) must hang freely from the bar of the saddle and the outside of the flap. The rider must not directly or indirectly tie any part of their body to the saddlery. (Safety Air Vests are allowed)

## Article 282 - Identification Papers, Registration and Results

7. All horses and ponies will be ~~re~~-registered annually by sending the appropriate forms together with fees and levies to the ESNZ. All horses and ponies must be a minimum of 4 years to compete.
