CRITERIA: Limited to 36 Jump riders & 16 Show Hunter riders. Open to riders up to 21 years old. All riders and their horses **MUST** be current ESNZ members to attend this camp. Riders will be selected on their previous year's ESNZ RIDER results and CV information.

COST: The cost of the training camp will be **\$200 per rider** plus SINEC costs. A deposit of \$150 will be required to be paid electronically by 20th August 2021 upon acceptance to the training camp and the balance to be paid electronically by 3rd September 2021

APPLICATION REQUIREMENTS for both Jumping and Show Hunter:

Please email your completed and signed application form along with a RIDER CV and any results from the previous season to Caitlin Adams, caitlin.adamsvmc@gmail.com . You will not find any results on the ESNZ database due to their reconstruction process sorry. A reminder, camp attendees are selected on their rider ability and results.

GENERAL INFORMATION – IMPORTANT:

- o Please remember this camp is aimed at coaching for you and your top horse/pony and these must be nominated as your jumping mount for coaching sessions.
- o ALL RIDERS will be required to stay onsite for the full duration of the camp including the final day until all pack up is complete
- o Riders may only attend either Jumping or Show Hunter, not both
- o All riders are required to provide a helper to assist with catering for instructors or cleaning
- o All riders under the age of 21 are required to have a parent or caregiver on site for the duration of camp
- o Riders may bring a maximum of one extra horse/pony to exercise only or for the flat lessons. No more than two equines per camp rider.
- o Pack Up Sunday – all riders not travelling more than 3 hours MUST stay and help with pack up. Riders who are traveling more than 3 hours who have requested to leave early on Sunday must arrive at camp early on Thursday to assist with set up. This will be explained during camp and no rider may leave without going through the check out process.
