**ASSOCIATED COMPETITIONS:**

• **NZ Young Rider Championship (Swarbrick Trophy)**

*Competitors will be eligible for this award from the **beginning of the calendar year** when they reach the **age of 16** until the **end of the calendar year** during which they reach the **age of 21**.*

Presented in 1957 by Waikato Area New Zealand Horse Society for the Dressage phase of the NZ One Day Event. Re-presented in 1986 for the NZ Young Rider Three Day Eventing Champion. Heelan Tompkins has been the most prolific winner of the Swarbrick, winning the trophy for five years in a row: 1996-2000.

• **NZ Junior Rider Championship (Lenamore Trophy)**

*Competitors will be eligible for this award until the **end of the calendar year** during which they reach the **age of 18**.*

Donated by Caroline Powell. The trophy was named after the horse Lenmore, or Ed as he is widely known to fans around the world. A popular eventing horse ridden by Caroline Powell until his retirement in early 2013. Lenamore won Burghley at the age of 17 and at the age of 19 won an Olympic Bronze medal at the 2012 London games in the Teams Three day event.

• **Young Rider (Bosun Trophy donated by Olivia Waddy)**

Awarded to the Young Rider with the highest points as per Swarbrick Scale.

• **Turn Out (FEI & National Classes)**

Best turned out Horse and Rider will receive a rosette and prize.

• **NZPCA Pony Club Award**

Rug awarded to highest placed Pony Club Rider





## FEI CODE OF CONDUCT:

The Fédération Equestre Internationale (FEI) expects all those involved in international equestrian sport to adhere to the FEI's Code of Conduct and to acknowledge and accept that at all times the welfare of the horse must be paramount and must never be subordinated to competitive or commercial influences.

At all stages during the preparation and training of competition horses, welfare must take precedence over all other demands. This includes good horse management, training methods, farrier and tack, and transportation.

Horses and Athletes must be fit, competent and in good health before they are allowed to compete. This encompasses medication use, surgical procedures that threaten welfare or safety, pregnancy in mares and the misuse of aids.

Events must not prejudice horse welfare. This involves paying careful attention to the competition areas, ground surfaces, weather conditions, stabling, site safety and fitness of the horse for onward travel after the event.

Every effort must be made to ensure that horses receive proper attention after they have competed and that they are treated humanely when their competition careers are over. This covers proper veterinary care, competition injuries, euthanasia and retirement.

The FEI urges all involved with the sport to attain the highest levels of education in their areas of expertise.

## CONDITIONS OF ENTRY – please read carefully & in full:

- a) **All** riders must provide assistance details with entries on the Google doc. The link will be sent to you on entry acceptance.
- b) The Organising Committee reserves its rights, as laid out in the wording of ESNZ Articles 610 and 611.
- c) Article 610 - Disclaimer of Liability. Neither the Organiser of any event to which these rules apply nor the NF nor any agent, employee or representative of these bodies accepts any liability for any accident, loss, damage, injury or illness to Horses, owners, Athletes, spectators, land, vehicles, their contents and accessories or any other personal property whatsoever whether caused by their negligence, breach of contract, or in any other way whatsoever.
- d) Classes 1, 2 & 3 will be run under all applicable FEI Rules and Regulations. Classes 4, 5, 6, 7, 8, 9, 10, & 11 will be run under all applicable ESNZ Eventing Rules and Regulations.
- e) Entries online at [www.equestrianentries.co.nz](http://www.equestrianentries.co.nz).
- f) Incomplete or incorrect entries will be returned and deemed as not received.
- g) Any entries received from the date of closing will incur \$20 late fee and will not be entitled to refunds.
- h) For Classes 1, 2, 3, 4 & 5 qualification are required for each Rider and Horse. Please refer to the MER Table on the ESNZ website - [www.nzequestrian.org.nz](http://www.nzequestrian.org.nz) - under Eventing/Resources/Riders/Minimum Eligibility Requirements. If in doubt, contact ESNZ Eventing Sport Manager first and then the Event Secretary.
- i) **All** riders need to be full ESNZ members for classes 1, 2, 3, 4, 5, 6, 7, & 8. Riders entering in classes 9, 10, & 11 must add an ESNZ Casual Membership - \$15/rider (for riders with no introductory membership).
- j) Classes 7, 8, 9, & 10: Horses not registered with ESNZ may enter under ESNZ Casual Equine Registration (\$5 per horse). Eventing Equine Flexi Start Levy for Class 6 only - \$15/horse (for Horses without an annual start).
- k) **All** Riders and Horses competing in Classes 1, 2 & 3 must be registered with the FEI.
- l) **All** Riders & Horses in Classes 1, 2, 3, 4, & 5 must have their Official ESNZ Identification Papers fully completed (i.e. must have appropriate stickers and the back cover identification completed and verified by ESNZ) and available for inspection.
- m) **All Horses entered in Classes 1, 2 & 3 must be accommodated on the grounds for the duration of the event (Vet Regs Art. 1023 IV 10).**
- n) **All** Horses competing in CCI4\* - L, CCI3\* - L, & CCI2\* - L must complete an Arrival Inspection.
- o) **All** Horses in Classes 4, 5, 6, 7, 8, 9, 10, & 11 that will be stabled, must complete an Arrival Inspection.
- p) Back number holders required for all Riders and can be pre-ordered from the Event Secretary (\$37.00).

- q) **Payment of all entry fees must be made at the time of entry. Payments can be made by Direct Credit to 03 0855 0371245 00 - use your name, the event and date for identification. Alternatively, POLi and Paypal are available for paying entry fees at time of entry. No cheque payment accepted.**
- r) Scratchings as per Art 646. Requests for a refund to be made in writing within 7 days of the event.
- s) Please supply a current email address for draw, yarding and event information. Event entry status, draws, yarding and live results also available at [www.equestriantentries.co.nz](http://www.equestriantentries.co.nz).
- t) Only Riders with more than one Horse competing will be permitted to ride out of order.
- u) Prize money will be awarded at a ratio of 1 in 5 starters for Classes 4, 5, 6, 8, 9, 10, & 11 as per Art 619, ESNZ Eventing and 1 in 4 starts for Classes 1, 2 & 3 as per Art 505, FEI.
- v) Dogs must be on a leash or under control at all times.
- w) All classes are part of ESNZ National Series.
- x) The Rider Shop/Rangiora Equestrian Supplies XC Style Prize will be awarded at CCN105 and below.
