General Event Conditions & Information

- **Bank Account:** BNZ Taupo, National Equestrian Centre **02-0428-0287292-25** Ref: Sept HT & EE entry #.
- **Dogs-** must be on a leash (no longer than 5m) at all times & to be under control of suitable person. Failure to comply will result in fine for owner (multiple fines may result in dog being removed from the grounds). All proceeds to NEC. Minimum fine per offence \$50.
- **Non-competition Horses** – please check with Event Secretary that there is available space for these – then please book via with your Entries & pay the Facility Fee & accommodation.
- **ESNZ/ESNZ Eventing Registration** – All athletes must be ESNZ Members to compete, casual membership is available for CCN80-S. Horse registration and discipline annual start required for CCN1*-S and above, casual equine registration is available for CCN105-S and below. Please contact ESNZ office for new memberships or registrations.
- **Camping/Yarding for Event:** Facility Use Fee – \$32 per horse; Camping \$30 per truck; Camping with Power \$50 per connection (Limited); Stable \$60 per horse (Limited); Covered Yard \$52 (Limited); Paddock \$32 per horse (Minimum 2 horses per paddock); Open Yard \$24. If you are arriving prior to Friday – you will need to pay extra facility, camping & yarding fees. Please notify Event Secretary.
- **Late Payments** – will incur the **Late Fee of \$25 per horse** if money is not in the bank account two days after entries close.
- **Late Entries** – will incur the **Late Fee of \$25 per horse** & if payment not received within 48 hours of entry, Late Payment Fee also.
- **Prizes** – At time or program being put together, No formal Prizegiving – Prizes & placings should be available 30 mins after Final confirmed results, so long as there are no queries. **Prizes will not be posted out – some classes have sponsored product that will require collecting.** Prizes paid out on ratio 1:5.
- **Refunds** – ALL classes 80% of entry fee, full yarding/camping included up to 48 hours before start of competition. Refunds will be paid electronically into your bank account 20th month following event. Other refunds at OC discretion. Refer Article 646 1.1 ENZ Rules. All Refund requests must be in writing & initial request put through Evo Events – this will be your official scratching time/date.
- **Refreshments** – available on the grounds.
- **Draft Timetable** – Dressage & Showjumping Saturday – Dressage may commence at 7.30am. XC Sunday 8am.

- This event is run under ESNZ eventing rules – effective 1 August 2023 and ESNZ General Regs – including membership & registration requirements.
- All Horses attending must be allocated & use a yard – including horses competing that are not staying. **NO HORSES ARE TO BE TIED TO TRUCKS/FLOATS, for this event** – the grounds are under repair.. This is a request from NEC, please respect this. Consequences for non-compliance.
- **Numbers - New ruling 2023/24 where back numbers are required on athletes for all phases & warmup/schooling from 1* and below. Back numbers to be worn for schooling & XC for 2* and above.** All horses must always have an ID (either a personal ID or their competition number) on them whether being ridden or in the yards as per Article 651.
- The organising committee reserve the right to restrict entries as necessary, alter classes & prizes as required. Please Note that some Prize Money may be swapped for sponsored product or vouchers – Refer Article 611 ENZ rules.
- If any class is over-subscribed with entries, waitlists will operate. Article 643
- Draw & yarding will be emailed to you or you can view it on Evo Events www.evoevents.co.nz from Wednesday prior to the event.
- **All local riders are encouraged to volunteer in some way – Please offer some help in any capacity.** We need your help to run this event 😊
- **Liability: Article 610:** Neither the Organiser of any event to which these rules apply nor the NF nor any agent, employee or representative of these bodies accepts any liability for any accident, loss, damage, injury or illness to horses, owners, riders, spectators, land, vehicles, their contents & accessories or any other personal property whatsoever whether caused by their negligence, breach of contract, or in any other way whatsoever.
